Qatar Airways was voted the World's Best Airline for the eighth time in 2024 by Skytrax. The airline continues to be recognized for its excellence in service, including 'World's Best Business Class'.

PASSENGER GROWTH

In the first half of 2024, the airport welcomed 25.9 million passengers, marking a 25% increase compared to the same period in 2023. The total passenger count for 2024 is expected to exceed 50 million.

QATAR INVESTOR VISA PROGRAM


Offers temporary residency to investors who purchase Qatari real estate, with a minimum investment starting at 728,000 QAR (200,000 USD).
