Interview Summary	Maurice Walsh talks about growing up in Kilmoyley, an area in Kerry with deep rooted hurling traditions. His parents interest in the GAA is discussed, as is his own involvement with club, school and university. Walsh talks about returning home to play for Kilmoyley at weekends and the lapse in his GAA participation. He mentions his marriage into a strong GAA family and his re-connection with club life through the Mungret club. Walsh considers the changing structures of the Mungret club, the difficulty of maintaining involvement after underage, given various counter-attractions. Walsh talks also about the prospects of his own children's emigration and the role of the GAA in easing their transition to a life abroad.

	00:02:25 Discusses his own involvement with Kilmoyley and Causeway Comprehensive. Mentions their record in colleges competitions and playing alongside brothers.
	00:03:09 Refers to his move to Limerick for college and playing for University of Limerick.
	00:03:42 Talks about returning to play with Kilmoyley and playing in a county final in 1983.

	00:05:15 Talks about work and family commitments and becoming involved with Mungret – attending club on the night of a Minor success in 1993.
	00:05:40 Discusses the social life of the Mungret club and the role of families within the club.
	00:06:30 Considers the improved organisation of underage and problems of maintaining them at adult level – refers to attractions of the city and competition from other sports.
	00:07:20 Interviewer mentions the role of schools and the influence of a Principal who came to Mungret from Cork. Mentions names of other teachers.
	00:08:04 Discusses the scattering of club members and the importance of them maintaining a link with the GAA.
	00:08:38 Anticipates the emigration of his own children and refers to the GAA as something they can take with them.
