


Hotel Floor Plan







Your Visit to the Capitol



TIPS FOR EFFECTIVE ADVOCACY

Be concise. Remember, legislators are inundated with phone calls and emails from constituents and lobbyists. Your message, whether communicated orally or in writing, should be brief and to the point.

Be specific. If talking about legislation, provide the bill number, author of the bill, and a summary of what the bill is about when you contact your legislator. In addition, let them know how the legislation will impact your city. If there is no legislation yet, be specific about the issue and how it affects your city.

Don't expect your legislator to be an expert on every bill. Each session, more than 1,000 bills and resolutions are introduced. If your legislator is not familiar with the bill you are referring to, don't be surprised or offended. It may be the first time they've heard about it.

Stay in touch. Exchange contact information and talk about how your legislator would like to hear from you during the session. Reach out periodically to thank them for their service and follow up on any specific bills or issues.

Don't burn your bridges. It's natural to be disappointed if your legislator doesn't vote the way you ask them to, but don't let one vote destroy your relationship. Remember, you're going to need their support on many other issues.

Communicate feedback or insights gleaned from legislators back to GMA lobbyists.

MUNICIPAL PRIORITIES:

Things to Discuss with Your Legislators

Municipal Revenues

Share with legislators that property taxes remain a core revenue source for cities, supporting essential services such as police, fire, infrastructure maintenance, and basic operations. Emphasize that proposals to freeze property assessments would significantly erode local tax digests over time, limiting cities' ability to provide services and respond to growth. Reinforce that local referendums on homestead property tax relief should remain a local option, allowing voters and city officials to determine what best fits their community. Remind legislators of the critical role local sales taxes, such as LOST, SPLOST, TSPLOST, and FLOST, play in funding both daily operations and major capital projects. Emphasize that additional hurdles or delays in renewing local taxes can disrupt long-planned infrastructure investments and increase costs. Share examples of rising service and construction costs and note that sales tax revenue helps offset property tax burdens for residents.

Housing

Share your city's need for additional housing options across price points and housing types. Reinforce that city officials are closest to their communities and best positioned to balance growth, infrastructure capacity, neighborhood character, and resident priorities. Ask legislators to support policies that preserve local decision making so cities can plan for and meet their future housing needs responsibly.

Low-Interest Financing

Emphasize the importance of access to lower interest financing tools that help cities deliver essential infrastructure. Note how stable financing options allow cities to plan long-term, manage debt responsibly, and stretch limited local dollars further.

Investment Pools

Highlight the value of local government investment pools as a safe and efficient way for cities to manage public funds and earn modest returns. Stress the importance of preserving flexibility for cities to participate in these pools without unnecessary restrictions, ensuring responsible stewardship of taxpayer dollars and stable cash management practices.

Workforce Development

Share with legislators the growing challenges cities face in recruiting and retaining skilled workers, particularly in public safety, public works, utilities, and technical fields. Emphasize that a strong municipal workforce is essential to service delivery, public safety, and economic competitiveness statewide.

Where can I find my legislator at the Capitol?

Your legislators maintain busy schedules throughout a typical day during the legislative session, so effectively gaining facetime with them can often depend on the time of day:

- When the House and Senate are meeting, you can attempt to catch your legislators in the halls outside the chambers or request that they come out of the chamber to meet by electronically contacting them or sending a message using a page.
- When the House and Senate are not meeting, try stopping by their legislative office. The legislature's website will provide their office number either in the Capitol or CLOB (Coverdell Legislative Office Building across Capitol Sq. SW).

How do I get to the Capitol from the hotel and what do I need to bring with me?

Buses will be available on Monday to shuttle city officials between the Omni Atlanta and the State Capitol, between 9:00 am and 1:00 pm. The entrance to the building is off of Capitol Square SW on the south end of the Capitol to the left of the stairs. You'll need to enter through a security screening and will need a photo ID.

Is there a place to get water, coffee, or a bite to eat?

There is a snack bar located on the ground floor of the Capitol near the security entrance which has several vending options.

There are two cafeterias on Capitol Hill and the surrounding areas:

- Café 244: Located on the 1st floor of the 244 Washington Street building.
- Capitol Commons: Located in the Floyd Building across from the State Capitol.

When in doubt, ask a GMA staff member! Our GR team members will be around the Capitol and can assist you.

GMA Awards Luncheon Recognitions



Visionary City Award

The Visionary City Award is a joint award offered by Georgia Municipal Association and Georgia Trend Magazine. The award is annually bestowed to nine cities—three from each population size group: under 4,999, 5,000-24,999 and over 25,000. This award honors cities that have created positive community change through effective civic engagement and collaboration. This award is presented at the annual Cities United Summit.



City and Organization of Civility

The City of Civility designation recognizes cities that commit to fostering civility in governance by promoting professionalism and respect in all interactions, whether in person, online, or in written communication. Qualified organizations are eligible to receive an Organization of Civility designation. New and recertified designees are recognized twice a year - at the annual Cities United Summit and GMA's Annual Convention.



City and Organization of Ethics

The City of Ethics program promotes ethical governance by raising awareness of ethics at the local level and encouraging proactive measures to address concerns. Cities that demonstrate their commitment to ethical principles can earn the “GMA Certified City of Ethics” designation. Counties and qualified organizations are also eligible to receive an ethics designation. New and recertified designees are recognized twice a year - at the annual Cities United Summit and GMA’s Annual Convention.



Georgia Economic Placemaking Collaborative

The Georgia Economic Placemaking Collaborative is a two-year place-based economic development program that provides participating communities with education, facilitation, technical assistance, networking, peer learning, and incentives to help identify their community assets and develop a locally based placemaking strategy.
