Legal Services


RSLWA has established an agreement for Legal Aid WA to set up a new service within ANZAC House that will assist Veterans and their families to make submissions to the Defence and Veteran Suicide Royal Commission.

A separate monthly legal service will soon be available at ANZAC House Veteran Central for veterans and their dependants.

On a fee-for-service basis at discounted rates, the service will be available from Monday 18 October.

In cases of financial hardship, RSLWA may be able to assist with the cost of either a Will or Power of Attorney.

Facebook: High Court upholds potential liability for the defamatory comments



State Branch wishes to inform all Sub-Branches of an important new development that may impact on inappropriate postings on social media.

In a significant decision handed down in early September, the High Court has confirmed that parties who create a Facebook page are potentially liable for defamatory comments from third parties.

This is a landmark decision that requires individuals and businesses to rethink how they manage social media engagement with third parties.

The practical effect of the decision is to require a greater degree of oversight by social media managers before third party content is made publicly accessible.

The potential risk arising from third-party content on social media accounts is most easily managed by removing the ability for third party comments to be made, or limiting who can do so.

An alternative approach is to proactively moderate third-party contributions prior to them being published. This is a feature available to Facebook administrators who can block posts with particular keywords, activate a profanity filter and/or require approval prior to posts being published publicly. Although this results in less transparency for users of the platform, the reduction of risk is arguably justified. – Special Counsel, Hamish McNair. [Download the full article here](#)
