INSTALLATION INSTRUCTIONS FOR ADJUSTABLE WALL BAR

The installation of your new Delta[®] adjustable bar unit is simple and easy requiring no special tools or skills. Caution: Use care to avoid marring or scratching chromed and plastic surfaces. A personal shower offers numerous possibilities of connections to water supply. The hose will connect easily to the shower arm, elbow at the shower outlet, Delta[®] shower diverter (permitting existing shower to

remain in use), or Delta[®] diverter tub spout (permitting this shower to be added to baths without a shower). It is important to establish your water supply connections first, as this avoids mounting the bar too far from the water supply outlet, creating excessive strain on flexible hose. As subsequent instructions specify, the bar should be mounted in a vertical position at the most convenient height.



Your hose is of high quality chrome plated spiral wound around a rubber inner liner. It will provide many years of quality performance with proper care. Avoid the following conditions which may weaken or damage your hose and void your warranty.

Do not pull, strain, stretch, or jerk hose.

Do not wind, twirl or twist hose.

Do not bend, knot, coil or crimp hose.

Select Location



Your bar unit is a beautiful bath accessory and should be located so it looks good and performs as intended. Pictured are some typical installations as suggestions only, pick a location that suits your family's needs.



Select a convenient height based on your family's needs. Note: Locate so there will be slack in the hose when shower is in extreme up or down position.

Mounting Bar



Place end mount of wall bar into the mount - do not tighten the set screw.



Drill hole for top mount. Use 1/4 inch carbide drill for ceramic tile.



Align bar and mark bottom as in step 5.



Position bar on wall at desired position.



Insert screw anchor.



Remove bar from both mounts. Secure lower mount to wall as in steps 7-9 with Allen set screw facing down. Replace bar onto mounts. Check alignment with level. If not plumb, remove bar, loosen mount screws and adjust accordingly, retighten screws and replace bar.



Draw circle around top mount with soft pencil.



Secure mount to wall with screw. Note: Allen set screw must be at top of mount.



Tighten Allen set screw on both top and bottom mounts.



Remove bar mount from bar. Place in marked position on wall and mark center screw hole on wall. Do not mark lower mount at this time.



Place bar into mount. Do not tighten Allen set screw.

CAUTION: Delta[®] Wall Bars are not to be used as grab bars!

Limited Warranty on Delta® Faucets

Parts and Finish: All parts (other than electronic parts and batteries) and finishes of Delta® faucets purchased from authorized Delta sellers are warranted to the original consumer purchaser to be free from defects in material and workmanship for as long as the original consumer purchaser owns the home in which the faucet was first installed. For commercial purchasers, (a) the warranty period is ten (10) years for multi-family residential applications and (b) five (5) years for all other commercial applications, in each case from the date of original purchase. For purposes of this warranty, the term "multi-family residential application" refers to the purchase of the faucet from an authorized Delta seller by a purchaser who owns but does not live in the residential dwelling in which the faucet is initially installed, such as in a rented or leased single unit or multi-unit detached home (duplex or townhome), or a condominium, apartment building or community living center. The following installations are not considered multi-family residential applications, are excluded from the 10-year warranty and are subject to the 5-year warranty: industrial, institutional or other business premises, such as a dormitory, hospitality premises (hotel, motel or extended stay location), airport, educational facility, long- or short-term healthcare facility (hospital, rehabilitation center, nursing, assisted or staged-care living unit), public space or common area.

Parts and Finish for Delta[®] Recertified Faucets: Delta Faucet Company offers for sale online Delta[®] Recertified faucets. Delta[®] Recertified faucets only include faucets that have been certified as such by Delta Faucet Company. All parts (other than electronic parts and batteries) and finishes of these Delta[®] Recertified faucets are warranted to the original consumer purchaser to be free from defects in material and workmanship for ten (10) years from the date of original purchase. For commercial purchasers, the warranty period is one (1) year from the date of original purchase.

Electronic Parts: Electronic parts (other than batteries), if any, of Delta[®] faucets purchased from deltafaucet.com or authorized Delta sellers are warranted to the original consumer purchaser to be free from defects in material and workmanship for five (5) years from the date of original purchase or, for commercial purchasers, for one (1) year from the date of original purchase. No warranty is provided on batteries.

What We Will Do: Detta Faucet Company will repair or replace, free of charge, during the applicable warranty period (as described above), any part or finish that proves defective in material and/or workmanship under normal installation, use and service. Detta Faucet Company may, in its sole discretion, use new, refurbished or recertified parts or products for such repair or replacement. If repair or replacement is not practical, Detta Faucet Company may elect to refund the purchase price in exchange for the return of the product. These are your exclusive remedies.

What Is Not Covered: Because Delta Faucet Company is unable to control the quality of Delta products sold by unauthorized sellers, unless otherwise prohibited by law, this warranty does not cover Delta products purchased from unauthorized sellers. Any labor charges incurred by the purchaser to repair, replace, install or remove this product are not covered by this warranty. Delta Faucet
