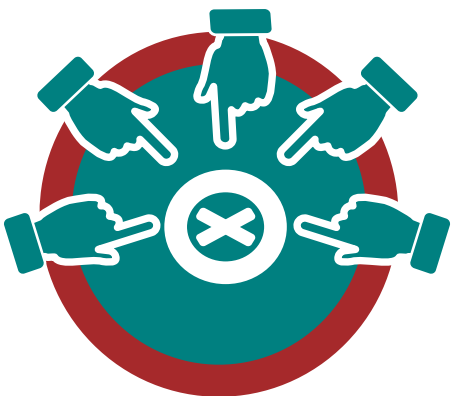
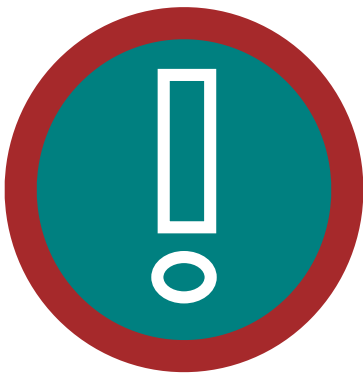


10 situations in which the ELSC can defend your right to advocate for Palestinian rights

KNOW YOUR RIGHTS

You want to know your rights around publicly supporting Palestinian rights including passing a boycott or divestment motion, hosting a Palestine related event, organising a protest or publishing a statement of support.

CHALLENGING THE IHRA DEFINITION

You want to challenge the implementation of the IHRA definition of antisemitism at your workplace, local government, university or student union.

DISCIPLINARY INVESTIGATIONS

You or your group are being investigated for activities related to Palestine advocacy both in-person and online. This includes investigations into alleged antisemitism, harassment and bullying, amongst other accusations.

INTERRUPTION OR CANCELLATION OF EVENTS

You are being pressured to cancel or alter an event on Palestine for reasons such as the implementation of the IHRA definition or because your panel or display is considered to be unbalanced or biased.

FALSE ACCUSATIONS

You have been falsely accused, in-person or online, of antisemitism, support for terrorism or breach of legislation or policy. This includes smear campaigns aided by media platforms, social media.



LEGAL THREATS

You are threatened with legal action or are worried about how the law or policy may interfere with your activism.



RESTRICTIONS ON YOUR RIGHT TO FREEDOM OF EXPRESSION

Your ability to express support for Palestinian rights is being unreasonably restricted and you wish to receive advice to challenge it, to protect yourself or your group.



THREATS TO ACADEMIC FREEDOM

Your ability to publish academic literature, conduct research or teach on the topic of Palestine, Israel or Zionism is being unreasonably restricted.



ONLINE SAFETY

You are targeted, harassed or bullied on social media. This includes being denied access to use social media platforms or being censored because of your affiliation with Palestine.



DISCRIMINATION

You believe you are being treated differently from others in a way that is unjust and you have reason to believe it is because of your support for Palestinian rights.
