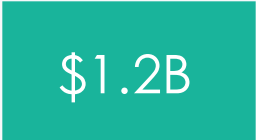

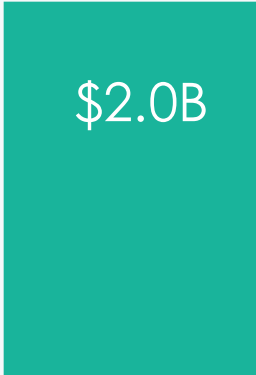

THE PROBLEM

The current model for health care is not sustainable



CHRONIC CONDITIONS ACCOUNT FOR >75% OF HEALTHCARE COSTS WORLDWIDE

- Chronic conditions are often poorly managed by patients at home, leading to complications and the need for ER visits, hospitalizations, long term care facility admissions and other costly interventions



READMISSIONS COST THE HEALTHCARE SYSTEM

- US Hospitals are subject to payment penalties when a Medicare beneficiary is re-admitted within a prescribed period with a complication that Medicare considers preventable
- ~20% of Medicare patients who are hospitalized end up back in the hospital within 30 days



PATIENT TRANSPORT WASTES PRECIOUS HEALTHCARE DOLLARS

- In the US, each year 2.2 million patients are transported between ERs to access the appropriate specialized care, at a cost of \$1.39 billion
- US Corrections spends >\$450 Million annually transporting inmates to ERs and doctors' offices
- Assisted living facilities in the US incur over \$5 Billion in transportation and medical costs associated with emergency room and physician office visits
