- 2. As of the date of this certificate, the following of our Subsidiaries are Material Subsidiaries: Centria S.r.I., Estra Elettrictà S.p.A., Estra Energie S.r.I., Estra Logistica S.r.I., Exo Energy Trading S.r.I. and Prometeo S.p.A.
- 3. Our audited consolidated financial statements as at and for the year ended 31 December 2015 (the "Financial Period") give a true and fair view of the financial condition of the Group as at the end date of such period (the "Determination Date") and of the results of its operations during such period.
- 4. As shown in, or determined by reference to, our audited consolidated annual financial statements as at and for the year ended 31 December 2015:
 - (a) our Net Financial Debt as at the Determination Date was 170,055 (EUR thousand);
 - (b) our Shareholders' Equity as at the Determination Date was 271,413 (EUR thousand);
 - (c) our Aggregated Regulatory Asset Base as at the Determination Date was 289,097 (EUR thousand); and
 - (d) our Consolidated EBITDA for the Financial Period was 55,192 (EUR thousand);

- (a) our Net Financial Debt-EBITDA Ratio was 3.08 to 1.00;
- (b) our Net Financial Debt-Shareholders' Equity Ratio was 0.63 to 1.00; and
- (c) our Net Financial Debt-Aggregated Regulatory Asset Base Ratio was 0.59 to 1.00.
- 6. By reason of the data set out above, we are in compliance with our obligations under Condition 5(a) (Limitation on indebtedness).
- 7. To the best of our knowledge, having made all due enquiry, there have been no events, developments or circumstances that would materially affect our ability to certify such compliance on the basis of the Group's financial condition as at the date of this certificate and our results of operations since 31 December 2015.
