1. As of the date of this certificate, the number of shares held by Permitted Holders (as far as we are aware) is 227.834.000, representing 99,8 per cent. of our share capital (excluding treasury shares)<sup>1</sup>.
2. The following of our Subsidiaries are Material Subsidiaries as at the date of this certificate: **Centria S.r.l., Estra Energie S.r.l., Prometeo S.p.A.**
3. Our audited consolidated financial statements as at and for the year ended 31 December 2018 (the "**Financial Period**") give a true and fair view of the financial condition of the Group as at the end date of such period (the "**Determination Date**") and of the results of its operations during such period.
4. As shown in, or determined by reference to, our audited consolidated annual financial statements as at and for the year ended 31 December 2018:  
(a) our Net Financial Debt as at the Determination Date was **251.974 (EUR thousand)**<sup>2</sup>;  
(b) our Shareholders' Equity as at the Determination Date was **325.253 (EUR thousand)** and  
(c) our Aggregated Regulatory Asset Base as at the Determination Date was **298.500 (EUR thousand)**.

5. On the basis of the data set out in paragraph 4 above, as at the Determination Date:
- (a) our Net Financial Debt-EBITDA Ratio was **3.55 to 1.00** and
  - (b) our Net Financial Debt-Shareholders' Equity Ratio was **0.77 to 1.00**.
6. By reason of the data set out above:
- (a) we are in compliance with our obligations under Condition 5(a) (*Limitation on indebtedness*); and
  - (b) no RAB Event has occurred.
7. To the best of our knowledge, having made all due enquiry, there have been no events, developments or circumstances that would materially affect our ability to certify such compliance on the basis of the Group's financial condition as at the date of this certificate and our results of operations since 31 December 2018.
8. In addition, for information purposes only, we certify that, as at the Determination Date and as shown in, or determined by reference to, our audited consolidated annual financial statements as at and for the year ended 31 December 2018:
- (a) our Aggregated Regulatory Asset Base was € 298.500; and
