Prescription Drug Safety: Know the truth Curriculum Guide

#### **COURSE MISSION**

This course intends to empower high school students with the skills and knowledge to make safe and healthy decisions about prescription drugs through a public health and evidence-based approach.

#### **COURSE DESCRIPTION**

The course will educate students about the potential dangers of misusing prescription drugs and the impact misuse can have on their physical and mental health, their relationships and communities, and their future. Through personal stories and interactive scenarios, students will learn about what constitutes appropriate use, proper storage and disposal, misuse and addiction (or substance use disorder), and treatment and recovery. By developing skills and strategies to prevent prescription drug misuse, students will become confident, empowered, and safe users of prescription drugs. They will also learn how to support others in need, including specific steps and instructions for responding to an overdose situation. Last but not least, the final module of the course is designed to raise awareness about the fentanyl crisis related to the rise of counterfeit pills in the United States, empowering students to stay safe and help others do the same.

#### **COURSE OVERVIEW**

Treatment and Recovery	Students learn about what treatment and recovery look like through a personal story.
Self Check-In	Students have an opportunity to check in with their own prescription drug use and determine if they need help.
Warning Signs	Students learn the warning signs of three common types of prescription drugs: opioids, depressants, and stimulants.
Resisting Barriers to Help	Through quick self-rating surveys, students reflect on what would stop them from reaching out or encourage them to help others. The feedback and tips that follow will empower students to offer support if they think someone they care about is struggling with drug misuse or addiction.
Responding to Overdose	Students review the four important steps to responding to an overdose, so they can be prepared by knowing what to do.
Fentanyl Facts	Students explore some of the basic facts about fentanyl.
Counterfeit Pills	Students learn about what counterfeit pills are, why they are dangerous, and what they can do to stay safe.
Fentanyl Overdose	Students learn about how to respond to an overdose situation specifically involving fentanyl.

The course is ungated. Students can take as many modules as they want in whatever order they like, although completing all modules from M01 to M08 is recommended for deeper understanding. Each module is designed to measure learning gains with pre- and post-assessment questions.

#### **DETAILED COURSE OUTLINE**

Each module in this course ends with a "Resources" page, where students can get more information on seeking help if they need support related to prescription drug misuse. Included in the resources are National Helpline, Substance Abuse Treatment Referral Locator, Narcotics Anonymous, Crisis Text Line, The Trevor Project, NEXT Distro, the Drug Enforcement Administration's resource page, and the Food and Drug Administration's flush list for certain medicines. These resources are also available in a menu panel throughout the online course experience, providing access at any point in the course.

#### Module 1: The Basics

Students become familiar with the basics of prescription drug misuse.

#### **Learning Objectives**

- Identify the common "street" and brand names of the 3 major prescription drug categories.
- Describe the positive effects on those with valid needs and prescription.
- Illustrate the potential negative effects on the brain and body if the drug is misused.
- Explain the possible legal consequences of misusing prescription drugs.

Prescription Drug Misuse & Prevention	The video gives an overview of the module and forms the foundation for understanding the benefits and risks of prescription drugs.

What Are Prescription Drugs?	Students learn about what prescription drugs are.
What Is Prescription Drug "Misuse"?	Students review what prescription drug misuse means.
Types of Prescription Drugs	Students explore three types of prescription drugs: opioids, depressants, and stimulants.
Opioids	Students dig deeper into opioids, including their medical use, how they work, their side effects, results of misuse, illegally produced opioids, and opioid brands and street names.
Depressants	Students dig deeper into depressants, including their medical use, how they work, their side effects, results of misuse, and depressant brands and street names.

Stimulants	Students dig deeper into stimulants, including their medical use, how they work, their side effects, results of misuse, non-clinical use, and stimulant brands and street names.

Driving and Prescription Drugs	Students learn about the dangers and consequences of driving under the influence (DUI).
Prescription Drugs: A Double- Edged Sword	The module gives a summary of the learning and reinforces the importance of proper, safe use of prescription drugs.
Resources	The module provides a list of resources students can refer to if and when they want to get more information or reach out for help.
Quiz/Your Score	Post-assessment questions measure learning gains from the module. Students need at least a 70% to pass.

### Module 2: Science of Addiction

Students explore how addiction, or substance use disorder, can affect the brain and body—knowledge that can ultimately help prevent the development of a substance use disorder.

#### Learning Objectives

Students will be able to ...

- Explain that addiction is a clinical diagnosis that anyone can develop.
- Describe how drugs impact the brain and can lead to addiction problems.
- Define terms such as "withdrawal" and "tolerance" and their relationship to addiction.
- Describe how people can manage their addiction and sustain their recovery in a supportive environment.

# **Module 3: Understanding Prescriptions**

Through a case study, students become familiar with properly reading a prescription label and disposing of unused drugs.

#### **Learning Objectives**

Students will be able to ...

- Explain the importance of following prescription instructions precisely.
- Describe the factors that doctors consider when writing a prescription for an individual.
- Read and understand prescription labels, including caution or risk statements.
- Store and dispose of unused drugs safely and appropriately.

Reading Prescription Labels: An Important Life Skill	The module gives an overview of why reading prescription labels and following the instructions are important.

Proper Storage and Disposal	Students review why it is important to properly store and dispose of unused prescription drugs.
Proper Storage	Students dig deeper into proper storage and learn about how they can safely store prescription drugs.
Proper Disposal	Students dig deeper into proper disposal and learn about how they can safely dispose of prescription drugs.
Be Informed	The module gives a summary of the learning and empowers students to always read and understand prescription labels.
Resources	The module provides a list of resources students can refer to if and when they want to get more information or reach out for help.

# Module 4: Safe Use

Students engage in interactive scenarios where they guide characters to make safe choices regarding prescription drug use.



# Learning Objectives

- Summarize why mixing prescriptions with alcohol is dangerous.
- Explain why using drugs for something other than the medication was prescribed for is unsafe.
- Illustrate the importance of sharing questions or concerns about prescription drugs with healthcare professionals.
- Make safe and informed choices in situations that involve prescription drug use.

Using Prescriptions Safely	The module gives an overview of the potential challenges of using prescriptions safely.
Before You Start	This page serves as a sensitive content warning and lets students know there are resources that can offer them support.
What You Know	Pre-assessment questions measure what students already know. Students won't get a score because this is not a quiz or a test.
Case Study: Veronica's Night Out	Students explore Veronica's situation and decide what she should do in an interactive scenario.
Feedback	Students are directed to a customized feedback page for their choice and learn about why mixing a stimulant and a depressant is dangerous.
Case Study: Anik's Personal Prescription	Students explore Anik's situation and decide what he should do in an interactive scenario.
Feedback	Students are directed to a customized feedback page for their choice and learn about harmful impacts of self-medication.
Case Study: Li's Concerns	Students explore Li's situation and decide what he should do in an interactive scenario.
Feedback	Students are directed to a customized feedback page for their choice and learn about the importance of communicating concerns about prescription drugs with healthcare professionals.
Staying Safe	The module gives a summary of the learning and reinforces what students can do to keep themselves safe and healthy.
Resources	The module provides a list of resources students can refer to if and when they want to get more information or reach out for help.

#### Module 5: Refusal Skills

Students learn about the risks of the recreational use of prescription drugs and strategies for effectively refusing to misuse them through interactive scenarios.

#### **Learning Objectives**

- Articulate that most students do not misuse prescription drugs and would support a friend's decision not to misuse drugs.
- Describe the potential side effects of taking prescription drugs outside of a prescription.
- Resist peer pressure and other influences to take prescription drugs outside a medical professional's advice.

ACTIVITY DESCRIPTION
The module gives an overview of why people may be pressured to misuse prescription drugs.
This page serves as a sensitive content warning and lets students know there are resources that can offer them support.
Pre-assessment questions measure what students already know. Students won't get a score because this is not a quiz or a test.
Students review a scenario where characters feel the pressure to misuse prescription drugs.
Students have an opportunity to explore each character's thought process and fact-check their concerns and questions.
With a quick Q&A, students learn about how misusing a prescription drug even one time can have consequences.
With a quick Q&A, students learn that most students don't misuse prescription drugs.
With a quick Q&A, students learn about how dangerous misusing prescription stimulants can be.
With a quick Q&A, students learn that misusing prescription stimulants doesn't help their grades.
Students engage in an interactive scenario where they can make a safe and healthy decision for a character.
Students decide how Rachel should respond to Jax, who is offering her a prescription pill.
Students are directed to a customized feedback page for their choice and learn about how to refuse prescription drug misuse effectively.

Resources	The module provides a list of resources students can refer to if and when they want to get more information or reach out for help.

# Module 6: Addiction, Treatment, and Recovery

Students learn that treatment works and recovery is possible from a real-life story and check in with themselves about their own prescription drug use.

## Learning Objectives

- Illustrate how treatment and medications can help people in recovery.
- Describe warning signs about one's own prescription drug use.
- Seek assistance if experiencing a problem with prescription drugs.

Rebekkah's Story	Students explore a personal recovery story of opioid addiction.
Video 1: Developing an Addiction	This video shows how Rebekkah became addicted to opioid painkillers.
Video 2: Treatment for Addiction	This video illustrates how clinical treatment and medications helped Rebekkah in her recovery.

Do I Need Help?	With a series of questions, students have an opportunity to check in with themselves about their own prescription drug use and determine if they need help.
Addiction, Treatment, and Recovery	The module gives a summary of the learning and reiterates that anyone can develop an addiction, treatment works, and recovery is possible.

# Module 7: Supporting Others

Students become familiar with how to support others in situations involving prescription drug misuse and overdose.

# Learning Objectives

- Identify signs of prescription drug misuse, addiction, and overdose.
- Resist barriers to action when witnessing a situation involving drug misuse.
- Illustrate how to support others and call for help in a potential overdose situation.

Overdose: What to Know	Students review the importance of being prepared and knowledgeable about how to respond to an overdose situation.
4 Steps to Responding to an Overdose	Students explore the four steps of responding to an overdose.
Step 1: Check for Signs	Students explore the signs of overdose.
Step 2: Call 911	Students learn about the most important step—calling 911—and review what information they should give.
Step 3: Administer Aid	Students learn about how to help the person overdosing, including the use of naloxone.
Step 4: Stay with Them	Students review what else they can do to help until help arrives.
Finding Support after an Overdose	Students reflect on how life-changing and traumatic an overdose can be for both people who have overdosed and those who have supported them, learning more about how they can all benefit from reaching out and seeking help.
You Can Be the Help	The module gives a summary of the importance of supporting others in situations involving drug misuse, addiction, and overdose.

# Module 8: Fentanyl—Fast and Fatal

Students learn about the facts, risks, and dangers of illegally made fentanyl and counterfeit pills that contain fentanyl.

- Summarize basic facts about fentanyl, including its types and effects.
- Illustrate overdose and poisoning risks of counterfeit pills containing illegally made fentanyl.
- Identify healthy strategies to stay safe and support others in the fentanyl crisis.

The Truth about My Brother's Overdose Death	The module kicks off with a personal story about an overdose death that involves fentanyl.
Before You Start	This page serves as a sensitive content warning and lets students know there are resources that can offer them support.
What You Know	Pre-assessment questions measure what students already know. Students won't get a score because this is not a quiz or a test.
Fentanyl 101	Students learn what fentanyl is and review more facts about it.
Fentanyl Types	Students review two types of fentanyl: pharmaceutical fentanyl and illegal fentanyl.
Fentanyl Names	Students learn about brands and street names of fentanyl.
Fentanyl Forms	Students explore two main forms of fentanyl: liquid fentanyl and powdered fentanyl.
Dangers of Counterfeit Pills	Students learn about what makes counterfeit pills dangerous.
Identifying Counterfeit Pills	Students explore different-looking pills that contain fentanyl.
Fentanyl Overdose	Students review how important it can be to be knowledgeable about and prepared for an overdose situation.
Responding to an Overdose	Students learn about how they can respond to an overdose that involves fentanyl-containing drugs.
When One Pill Kills	The character whose story has kicked off this module wraps it up.
Stay Safe, Stay Vigilant!	The module gives a summary of the importance of staying safe and being prepared in the fentanyl crisis.
