Exertis (UK) Ltd is opposed to slavery and human trafficking in any part of our activities or our supply chain. We are therefore committed to ensuring that we have adequate policies and procedures in place to identify and prevent these practices.

Our Business

- Monitor potential risk areas in our supply chains on a periodic basis.



Responsibility for ensuring that our procedures are adequate and are adhered to in all areas of our activities rests with the directors of Exertis (UK) Ltd.


Assurance and Key Performance Indicators
