80 years of history

Carlo Salvi's entrepreneurial adventure has been going on for more than 80 years and continues to this day in the name of innovation, evolution and new horizons. Founded in 1939 in Milan by Carlo Salvi and Eufemia Garlaschi in the midst of the Second World War, the company began by producing machines for the mechanical pickling of wire: the classic rolling machines. The first high-speed cold moulding machines were built in the early 1950s. In 1994, the founder passed away and the management and ownership of the company passed to Sergio Ziotti, who gave Carlo Salvi a much more management-oriented approach. In April 2016, another decisive change of direction: the acquisition of the company by the Swiss group Hatebur led by Claudine Hatebur de Calderon. A similarly family-owned company with a history similar to that of Carlo Salvi, specialising in the development and implementation of hot and cold moulding solutions, with its headquarters in Reinach. Carlo Salvi Spa is in Italy, the United States, China, and the United Kingdom, with subsidiaries all over the world including Japan, Germany, India and with almost 300 employees. The Hatebur range of products is an expression of the highest quality in the field of moulding machines and related equipment. The merger between Hatebur and Carlo Salvi has contributed to the creation of an optimal synergy between the two companies, with perfectly complementary markets and products, which now offer an even wider and more innovative range of products to the vast global customer base.

Carlo Salvi is ready to face a future full of novelty and change: "Before the second lockdown in 2020, we saw the economy rebound, with some sectors, such as the white goods industry and, to a lesser extent, the automotive industry, recovering. We expect re-shoring to increase in the near future, with industries reorganising to produce in Europe all those components that used to be purchased from Asia.
