# Legal steps explained

## Andrew Morgan, partner, explains how we conduct successful mesothelioma and asbestos claims.

As with all asbestos-related claims, it is necessary to show that a duty of care was owed to you, the injured person, by the party who exposed you to asbestos.

If you have been exposed to asbestos in the course of your employment, there is usually no difficulty in showing that you were owed a duty of care in those circumstances.

Sometimes there is exposure when family members bring dust home on clothing and tools. Alternatively you may have lived near to a factory manufacturing asbestos products.

It is usually possible to show a duty of care existed in these cases.

### Who's at fault?

If you were exposed to asbestos at work, we will need to identify the relevant employers and/or their insurers. We will undertake detailed investigations to locate the relevant companies or their insurers.

We have established a database of over 2,000 companies and their insurers, who have previously been investigated. In many cases, we will be able to pursue a claim even if an employer and/or its insurers no longer exist.

If we cannot find a company to sue or its insurer, we will advise about recovery under the Diffuse Mesothelioma Payment Scheme (DMPS) or any Government compensation schemes available.

### How was your illness caused?

Once the appropriate parties have been identified and the evidence of exposure reviewed, we will assess whether there is a reasonable prospect of proving that they were responsible for your condition.

Where there is a reasonable prospect of success, we will obtain a medical report from a consultant who is a specialist in asbestos-related diseases.

### How have you suffered?

We will obtain information and documents relating to financial loss including pension, loss of earnings and out-of-pocket expenses (both past and future) which can reasonably be attributed to your condition.

We will also quantify your claim for pain and suffering as well as any care requirements and other financial consequences of your illness.

### Asbestos conditions

Ask your GP or consultant exactly what the diagnosis is. Asbestos exposure can lead to various conditions – some more serious than others.

If you are suffering from an asbestos-related condition (like mesothelioma, asbestosis, or lung cancer) you may be able to claim damages for this condition, for the risks of your condition worsening and for the risks of contracting another asbestos-related condition in the future. In some cases you can claim “provisional damages” where you can make a fresh claim if you go on to develop a new asbestos disease in the future whilst getting some compensation now for your present illness.

You may also be entitled to some state benefits.

### Timescales

We recommend that you speak to one of our lawyers as soon as you are diagnosed. If you or one of your family suffer from mesothelioma your case can be fast tracked. We can often complete your claim in weeks or months.

Your claim must be issued at court within three years of your date of knowledge. In most cases, this is the date of diagnosis.

The rules can be complex but in some circumstances we can apply to the court to extend the time limit. Delay does prejudice any claim so it is important to set the wheels in motion as quickly as possible.

### Are court proceedings necessary?

Court proceedings are not always necessary. If they are, we aim to start them as soon as possible. With your permission we will approach the other side first with a view to negotiating a settlement.

This allows us to settle claims very quickly, often within three to four months. The vast majority of claims are resolved without the need for a trial.

### Compensation

We cannot say how much you will recover before our investigations have been completed. Claims are valued according to your personal circumstances and the severity of your condition. See further information on our ‘What you can claim for’ page (p14).

### Next steps

We will:

- take a detailed statement of your work history
- obtain your hospital and GP notes, scans and x-rays
- trace and contact any necessary witnesses
- draw on our archive of witness statements to help support your claim

# Claim against your employer

## We acted for Graham Mason who was diagnosed with mesothelioma at Southend Hospital.

Graham worked as a fitters mate for J.W. Coward & Co of Chelmsford in the 1960s. He worked alongside ladders in schools and hospitals where he was required to mix and strip asbestos from pipes and boiler work with his bare hands in tight confined spaces. His employer provided no protective equipment.

Graham began to notice intense chest pains and shortness of breath and was admitted to hospital. He was diagnosed with mesothelioma and was no longer able to undertake normal activities such as cooking, cleaning and gardening.

The company Graham worked for was long dissolved and had no assets. Insurers could not be traced by the Association of British Insurers. Fieldfisher searched their databases and was able to find two cases in which we had been able to pursue the company in the 1990s and had recovered compensation. AXA were identified as the responsible insurers for the company in those cases. AXA had no documentary or witness record of insuring the company but we were able to refer them to evidence from a director of the company taken in the 1990s to confirm that they were responsible for the insurance.

Despite initially defending the claim AXA finally agreed that they were responsible. We successfully negotiated a global settlement of £210,000, allowing Graham to obtain the compensation he deserves.





## Settlement for widow in 'out of time' claim

**We recovered damages for Jean Ambrose following the death of her husband from mesothelioma.**

We pursued a mesothelioma claim against Exxon Mobil (formerly Mobil Oil) who had exposed Mr Ambrose to asbestos while he was working there as a maintenance engineer from 1958 to 1984.

Mr Ambrose was diagnosed with mesothelioma when he was 76.

Mrs Ambrose cared for him during his illness until he passed away.

The case was out of time under court rules because Mr Ambrose had not issued a claim against Mobil within three years of his diagnosis. Mrs Ambrose was unaware of this.

Following the inquest the Coroner advised Mrs Ambrose to instruct a solicitor. She contacted two firms of solicitors who did not pursue her claim.

She eventually contacted Fieldfisher who decided to pursue her claim, even though the deadline for pursuing a mesothelioma compensation claim had passed.

We negotiated a settlement for Mrs Ambrose, arguing that Mobil were not disadvantaged by the delay as they had settled many asbestos claims in the past arising from the same circumstances, many of them conducted by Fieldfisher.



# Recovering costs for immunotherapy treatment

**Pamela Stubberfield was exposed to asbestos for about 6 months aged 18 when she worked for British Oxygen Company in Morden, South London, around 1962. Her job was to mix asbestos wool with water and cement to form components of acetylene welding tanks. The mixing machine she used generated asbestos dust.**

Pamela only worked for BOC for a short time. She then went on to get a degree and to pursue a career as a physicist, eventually working at the Atomic Energy Authority in Culham, near Oxford.

Pamela developed sarcomatoid mesothelioma, the most aggressive form, in 2016 when she was 83. She approached HASAG for advice and then instructed Andrew Morgan, Partner in Fieldfisher's Mesothelioma Team, to make a claim.

BOC still exists and is insured. Andrew wrote to them to make a claim but they did not engage in negotiations so Andrew issued Court proceedings in the Mesothelioma Fast Track at the Royal Courts of Justice in London.

Pamela's condition deteriorated rapidly. The sheath-like tumour had invaded her spinal column which caused her neurological problems. Her legs were also affected, impairing her mobility. Her life expectancy was severely compromised.

Pamela was identified through the NHS as being a possible candidate for immunotherapy using "Keytruda". This was a new treatment, not available on the NHS. From her own resources Pamela paid for the first two rounds of treatment in the hope it would arrest or reverse her symptoms. Her condition improved dramatically and it's fair to say that the treatment was life-saving.



Andrew went to Court and got judgment early for Pamela. He claimed for the future cost of Keytruda treatment, estimated at £250,000, as well as for the medical expenses that she had already funded. He obtained an interim payment of £50,000 for Pamela's injury itself plus a further payment of £14,000 for the cost of the initial treatment.

About two weeks before trial, the claim was settled on the basis that the employer pays Pamela a lump sum of £310,000 and then continues to pay directly for her treatment, for as long as it is needed. The total value of the claim is estimated to be about £550,000.

This was the first known settlement involving a claim for the cost of future immunotherapy with Keytruda where the insurer pays for all future treatment. This case set a precedent and provides a template for future settlements for mesothelioma patients who might benefit from immunotherapy. Sadly, Pamela lost her battle with this terrible illness and died in September 2018.



## Exposure from washing overalls

**We acted on behalf of the son of Mrs Scorer (as executor to her estate), who died of mesothelioma after washing her husband's dusty asbestos-covered overalls.**

The company that operated the Cape Asbestos factory where Mrs Scorer's husband worked no longer existed so the claim was bought against his father's employer Avery Dennison and also against the parent company (which had overall control over the factory), Cape Intermediate Holdings plc.

Cape relied on a large amount of disclosed material which purported to paint a picture of a very clean working environment. They suggested that any exposure to Mr Scorer was well within the HSE control limits set at the time. Witness statements obtained on the family's behalf described particularly dusty working conditions.

Mrs Scorer's son obtained a substantial settlement from both Defendants a week before the case had been listed for a three day trial in the High Court in London.

This was a test case as the employer's duty extended to advise/warn its employees (of the dangers of taking asbestos home) even when the employee was working at another's premises. In addition, owners/occupiers of premises (or their parent company in this case) have a duty to advise/warn visitors and contractors working at their site.

# Lung cancer claims

## We recovered compensation for our client who developed lung cancer from exposure to asbestos.

Mr Arthurs was exposed to asbestos as a young man between 1952 and 1954. He was employed as a pipefitter by C A Parsons on the construction of power stations at East Yelland in Devon and at Shoreham, in Sussex.

C A Parsons installed high pressure steam pipes in the upper parts and roof sections of power stations. Mr Arthurs' job involved working at heights to secure block and tackle for hoisting high pressure steam pipes into position.

Alongside him ladders worked to insulate ductings and pipes. Their work generated asbestos dust which contaminated Mr Arthurs' working environment.

He also assisted the grade A welders in the precision welding of high pressure steam pipes. His job was to "cut back" excess lagging on the pipework to allow the welder to get access to the pipework underneath.

Mr Arthurs also applied and removed the copper heating coils. These were insulated with asbestos weave that was in a poor state so that it crumbled as he handled it and gave off dust which he inhaled.

Many years later, as a result of this exposure, Mr Arthurs developed lung cancer which was diagnosed in the course of other medical treatment. He underwent a lobectomy and follow up surgery which kept him away from work for a few weeks on each occasion.



Mr Arthurs was left with a feeling of breathlessness on exertion but some years have passed since the surgery, so the prospects look good.

Mr Arthurs instructed Fieldfisher who took a full statement and was able to trace the insurers to make a claim.

Although it was intense, Mr Arthurs' exposure occurred over a relatively short period of only three years. In addition the exposure occurred in the early 1950s, before the link between asbestos exposure and lung cancer had been firmly established.

Mr Arthurs also benefited from his early surgery which had effectively removed the risk of lung cancer.

Andrew issued proceedings for Mr Arthurs and obtained an offer of £60,000, which Mr Arthurs was delighted to accept.



# Self-employed claims

**We recovered damages for our client, Mr Gent, who was suffering from mesothelioma.**

Mr Gent worked as an electrical contractor at the University of Surrey in the 1970s.

Together with two other electrical contractors, he formed a partnership. They tendered for work at the university. One project that the partnership secured involved working in the library.

Seventy-two year old Mr Gent was not provided with any protective clothing during this project. He remembers being covered in asbestos dust as he worked. He also moved asbestos ceiling tiles. They often broke, releasing dust.

Mr Gent, who was married with grown up children, was diagnosed with mesothelioma. He instructed Fieldfisher to investigate a claim against the University of Surrey.

The university denied liability and said that the library did not contain asbestos. They also said that they were not legally responsible for Mr Gent as he was not their employee.

We obtained records from the university.

They showed that the library building contained asbestos.

The university supervised Mr Gent's work. We argued that this equated to an employer-employee relationship.

Two days before trial, the university made a settlement offer that Mr Gent was happy to accept.

# What you can claim for

In a successful asbestos disease claim you can claim damages for the losses that you or a loved one have suffered. The amount of compensation that you could claim will depend on your personal circumstances but you will be able to claim:

## General damages

General damages are awarded for the asbestos condition that you have been diagnosed with and the pain, suffering and loss of amenity that it causes to you (or a loved one). The Judicial College Guidelines provide a range for the assessment of general damages and for asbestos disease cases. The ranges of general damages are as follows:

- Mesothelioma - £59,730 - £107,410
- Lung Cancer - £59,730 - £83,050
- Asbestosis and pleural thickening - £12,860 - £90,300 (depending on level of disability)

## Special damages

You will also be able to claim for financial losses that you or a family member have incurred as a result of your asbestos-related condition. The types of financial loss that you can claim vary but some examples include:

- Care and Assistance
- Lost Services
- Out of Pocket expenses such as travel and medical expenses
- Loss of Income
- Medical Treatment (see below)

We will discuss with you and your family the losses that have been incurred in your case and what we can claim for on your behalf.

## Private medical treatment

As part of your claim, it may be appropriate to include the cost of private medical treatment (such as immunotherapy) from the responsible party. Some medical treatment for mesothelioma is not available on the NHS. We will advise you on this at the outset of the claim and as your claim progresses.

If private treatment is recommended then we will seek to recover the full cost of this treatment from the paying party.

## Future loss

We may be able to bring a claim for the losses that you or a loved one are likely to face in the future for loss of income, services, care and support as a result of the asbestos-related condition that you are suffering with.

## Loss of a dependent

If you have lost a loved one to mesothelioma or another asbestos-related disease, we will look to make a claim on your behalf for the lost services, lost income and care provided. In addition, there may be a claim for statutory bereavement damages.

# Diffuse Mesothelioma Payment Scheme

The diffuse mesothelioma payment scheme (DMPS) has been making substantial payments to some mesothelioma sufferers since July 2014. Most people suffering from mesothelioma were exposed to asbestos at work and have been able to pursue claims against employers, though not always successfully.

In many cases, these employers have ceased trading by the time the mesothelioma appears, so that the sufferer has no employer to sue. In some cases employers liability insurance details cannot be located as insurance records are patchy and incomplete and in some cases insurance was simply not taken out.

Alongside the Government “no fault” arrangements and payments, in some circumstances, people with mesothelioma can apply for a payment from the DMPS. The Scheme is set up to make a payment where the Applicant can prove that he or she was exposed to asbestos in employment as a result of his or her employer’s negligence, and demonstrates that he or she has taken steps to find his or her employer’s insurer but without success.
