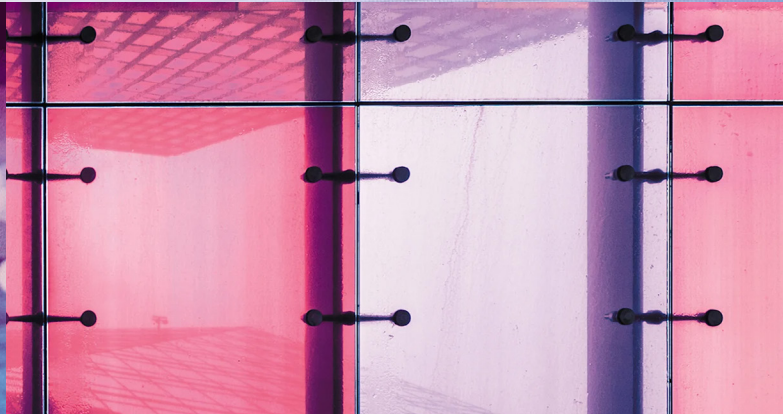

Not only did this opportunity allow me to develop new skills in respect of client relations, but I also learned to manage and take ownership of files, all of which are essential in a Solicitor role.


I recently completed the Professional Practice Course at Blackhall Place with the Law Society of Ireland, and I am continuing my rotations in the Public and Regulatory department.

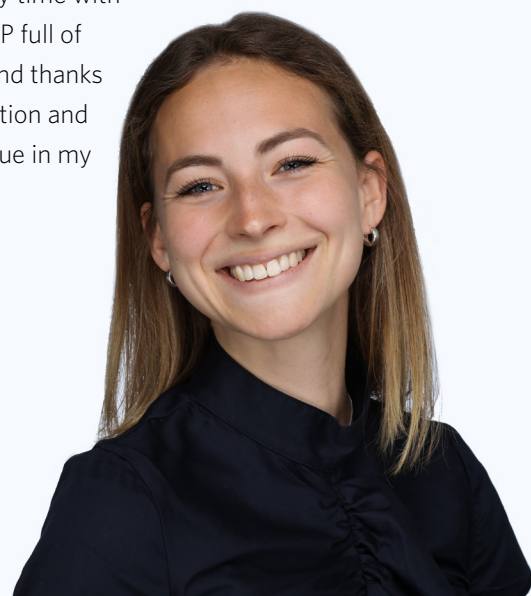
