NO PURCHASE NECESSARY TO ENTER OR WIN. Entry into this Contest constitutes your acceptance of these Official Rules.

CONTEST DATES: End Of The Roll’s Scan To Win Contest ("Contest") begins at 12:00 a.m. Pacific Standard Time ("PT") on September 5, 2022 and ends at 11:59 p.m. PT on November 6, 2022 ("Contest Period"). Entries will be accepted during the entirety of the contest period.

ELIGIBILITY: Contest is open to: (i) legal residents of Canada (except the province of Quebec); (ii) age 19 or older at time of entry. Disclaimer: Employees of End Of The Roll and their immediate families (meaning spouse, parent, child, sibling and their respective spouses, regardless of where they reside or those living in the same households, whether or not related), ambassadors, affiliates, subsidiaries, advertising and promotion agencies (collectively, "Contest Parties") are not eligible to enter or win. Contest is governed by the laws of British Columbia. Contest is subject to all applicable provincial and federal laws and regulations. Contest is void where prohibited by law.

HOW TO ENTER: Enter online by submitting a photo of the contestant in store, using the scantowin.endoftheroll.com website. During the **Contest Period**, visit any End Of The Roll location, take a photo of yourself in store, and submit the photo to scantowin.endoftheroll.com and provide all required information; your name, address and telephone number, and email address. Entries must be completed in store, during business hours, as prizeing will only be instantly awarded during this time. Only one entry is allowed per person during the Entry Period, no purchase necessary. Sponsor does not guarantee the receipt of any Entry. Sponsor reserves the right to disqualify for any reason, in its sole and absolute discretion. All prize values are in Canadian dollars, unless otherwise stated.

PRIZE DETAILS: 89 total prizes with a total value of \$26,300 will be awarded randomly, upon entry. Prizes will be 1 x \$5000 End Of The Roll Gift Card, 5 x \$1000 End Of The Roll Gift Cards, 20 x \$500 End Of The Roll Gift Cards, and 63 x \$100 End Of The Roll Gift Cards. Each gift card will only be valid at the store of entry where the photo was taken and entry submitted, and will only be awarded to the person who entered the contest. Your name and address on your entry must match the name and address on your government issued identification.

NO PURCHASE NECESSARY TO ENTER.

Winner must take the prizes as offered. This prize is non-transferable, nonrefundable, cannot be sold or exchanged for cash and cannot be used in conjunction with any other offer. Additional expenses are not included in the prize and are at the winner’s expense.

Sponsors reserve the right, in their sole discretion, to cancel, terminate, modify or suspend the Contest or any portion thereof, or to disqualify any individual implicated in any of the following actions, if for any reason:

Any Entrant who attempts to tamper with this Contest in any way shall be disqualified. In the event of dispute as to who submitted an online Contest Entry, the Contest Entry will be deemed submitted by the Authorized Account Holder (as defined below) of the email address submitted at the time of Contest Entry. For the purposes of these Official Rules, "Authorized Account Holder" shall mean the natural person assigned to an email address by an Internet access provider, on-line service provider or other organization responsible for assigning email addresses for the domain associated with the email address in question. Additional restrictions may apply.

Arbitration/Choice of Law: Except where prohibited, Entrants agree that any and all disputes, claims and causes of action arising out of or connected with this Contest shall be resolved exclusively by arbitration in the City of Vancouver and pursuant to the Rules of the Canadian Arbitration Association then effective, and any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred by Entrant with regard to this Contest, but in no event legal fees, punitive, incidental, consequential or other damages. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of Entrants and Sponsors in connection with the Contest shall be governed by and construed in accordance with the laws, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of the laws of any jurisdiction. The invalidity or unenforceability of any provision of these Official Rules shall not affect the invalidity or unenforceability of any other provision so long as the general intent of these Official Rules remains in effect. In the event that any such provision is determined to be invalid or otherwise unenforceable, these Official Rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.

WINNER SELECTION:

Each store location will have at least one \$100 gift card winner instantly awarded at random, while gift cards with a value greater than \$100 will be distributed randomly across all store locations. Each day of the contest, a store will be chosen at random to instantly award prize. If the store is closed, prize will be awarded by the store on the next available day the store is open. Once the store is chosen, a prize is selected at random from the remaining pool of prizes that have yet to be awarded. If the randomly selected prize to be awarded is a \$100 gift card, and the store location has already awarded a \$100 gift card, and there are stores that have yet to award a \$100 gift card, the random draw will be done again. If the randomly selected prize is greater than a \$100 gift card, that prize will be awarded, and a second draw will be conducted for a \$100 gift card by choosing a location at random, excluding all stores that have already issued a \$100 gift card through this contest. Once all stores have been awarded at least 1 winner of a \$100 gift card, all store entries will be eligible for the remaining \$100 gift cards. Once a valid store and prize have been chosen, a random time will be chosen to issue the prize instantly. The first entrant after the randomly selected time to enter the contest at the selected store will win. These random selections will be made electronically no later than 6pm PT the day prior to the prize being awarded.

The Winner will be notified instantly on the web page after submitting their entry. If selected as a winner, the potential winner will be required to execute the following to obtain the Prize: (1) A declaration of eligibility and liability release; (2) publicity release, including the consent of use of winners personal information including any statements and photographs; (3) a mathematical skill testing question; and (4) Any other affidavits, declarations, and/or releases or additional documents that may be required by the Sponsor and/or prize supplier(s).
