

## **ProMatDX Contest Official Rules**

## **Contest Prizes:**

- Monday: \$500 gift card to the attendee with the most engagement on the portal plus a \$500 donation to Feeding America in their name
- Tuesday: \$500 gift card to the attendee with the most engagement on the portal plus a \$500 donation to Feeding America in their name
- Wednesday: \$500 gift card to the attendee with the most engagement on the portal plus a \$500 donation to Feeding America in their name
- Thursday: \$500 gift card to the attendee with the most engagement on the portal plus a \$500 donation to Feeding America in their name
- Friday: \$500 gift card to the attendee with the most engagement on the portal plus a \$500 donation to Feeding America in their name
- Friday: Lucky Draw of a Door Prize between the five daily winners for a \$5,000 trip voucher plus \$5,000 donation in their name to Feeding America will be held on April 16<sup>th</sup>.

The leaderboard reflects cumulative points for the week. Daily winners will be announced at the end of each day. In the event that the daily leader is the same individual for multiple days, the next most engaged attendee who has not been a daily winner will be the daily winner for that day.

**How to Enter:** ProMatDX attendees are automatically entered when you log in.

The random drawing from the daily winners will be held at 6:00 p.m. on April 16, 2021 or at a later date, place, and time if required due to unforeseen circumstances. (See Disclaimer below.) MHI assumes no responsibility for unanticipated delays in holding such drawing.

The winning Finalist is ineligible for any reason whatsoever, MHI may elect in its sole discretion to hold another random drawing to determine an alternate winner. Any such alternate drawing is subject to scheduling by MHI without notice to any entrants. If no eligible potential Finalist Winner can be identified after reasonable attempts or no alternate drawing is deemed by MHI to be feasible or reasonable, MHI may in its sole discretion decide not to award any prize. itinerary/destination, but the trip's total package price of \$5,000 (including travel coordination fees) as organized through MHI's travel provider cannot be exceeded.

Taxes and Charges: The reporting and payment of all liabilities incurred as a result winning are the sole responsibility of Winner and are subject to the issuance of IRS Form 1099.
