## **ENTERING THE SITE**

- Gates at Parking Lot A will open at 6:00 AM for Exhibitors unloading and entry. Consult the judging program for all ring times.
- Your vehicle hangtag must be displayed upon entry and during vehicle staging. **Please remember to add your cell number to this tag.**
- In order to expedite entry to the site, please follow the directions of Site and Security Personnel who will direct to an unloading and grooming tent.
- Exhibitors will access the show site with their wristband (from your packet). Wristbands must be secured to their wrist and your dog entry ID should be in hand (no exceptions).
- MB-F personnel will be at the gate to assist those who had their packet held, or who have not received their mailed packet.
- Handstamps will be given each day for easy access in and out of the grounds.
- After unloading, proceed to the Queens Hall of Science to park. You must have your exhibitor hangtag on the rearview mirror to access this lot. One hangtag per entered dog was sent with your entry for the day your dog is shown.
- All grooming spaces have been specifically assigned and exhibitors/handlers may NOT alter their space in any way. Any problem with your space must be handled by MB-F. **NO EXCEPTIONS!**
- Monday exhibitors can arrive at Parking Lot A at the USTA on Sunday at 3 PM to unload and set up for Monday.
- Monday dogs can be left in the grooming tent overnight on **Sunday** night if needed. A liability waiver must be signed in order to have this privilege.
- **ALL MONDAY DOGS MUST BE REMOVED** from their grooming space by 6 PM on **MONDAY NIGHT** so that **TUESDAY** exhibitors and breeds **CAN** access their assigned grooming space (no exceptions).

- Tuesday dogs can be left in the grooming tent overnight on Monday night after 7 PM if needed. A liability waiver must be signed in order to have this privilege.
- All dogs **MUST** be out of the grooming tents by Midnight on Tuesday night. **NO EXCEPTIONS!**
- Your exhibitor wristbands (provided per entered dog - included in your exhibitor packet) will allow the exhibitor seating for the nighttime events at Ashe on the day your dog is entered in the show. The **EXHIBITOR** section is on one end zone of the Ring.

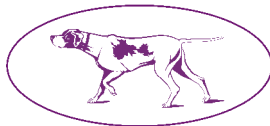

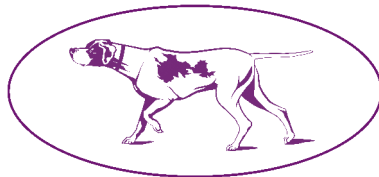

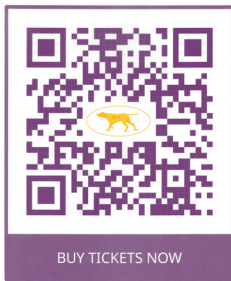


# RULES AND PROCEDURES

## EXHIBITOR TICKET INFORMATION

1. **Regardless** of the ownership of the dog(s) two (2) exhibitor's wristbands are provided for show access and Group seating on the day your dog is entered in the Show.
  - A. These wristbands are needed for admittance.  
**NOTE:** Wristbands **MUST** be secured to your wrist for show entry - no loose bands.  
The person accompanying the dog must show their wristband.
  - B. **DO NOT BRING ANY DOGS THAT ARE NOT ENTERED.** There is no provision for unentered dogs at this show. There is no space for these dogs.
2. All regular exhibitor wristbands, dog ID's, etc., are sent to the email and postal addresses noted on the entry form. Owners or the owners' duly authorized agent are responsible for the correctness. **No duplicate packets are mailed.** See Premium List, page 13, item #9 for mail options.
3. Regular exhibitor packets returned by the Post Office will be held at the show at the Superintendent's Office.
4. **NOTE: Juniors receive an exhibitor admission wristband for each day plus two guardian wristbands per entry for all show days. Misuse of the Junior wristband could result in an Event Committee Hearing.**

This will take place in Parking Lot A on the day your dog is entered in the show (See General Notes on pages 9-10).

Please utilize Grand Central Parkway Exit 9E or Whitestone Expressway, Exit 13D for the shortest route to Parking Lot A.

When entering the event, please keep your Exhibitor hangtag on the rearview mirror (and write your cell on it before hanging). In order to get everyone in and out efficiently, we suggest that you have an extra person with you to assist with the move in and stay with your dog(s) in the grooming tent while the second person parks the car in Exhibitor Parking at the nearby Queens Hall of Science. Please follow signs from Parking Lot A to the Hall of Science after unloading. Site Control personnel will be on hand to assist you with staging, directions and unloading.

Shuttles will be running to get you back to the USTA grooming tent after parking your vehicle (the ride is less than 10 minutes).

Shuttles will also be running between the LaGuardia Marriott, LaGuardia Plaza/Hampton Inn and Aloft Hotels on Ditmars Blvd. and Parking Lot A.

1. There is NO RV Parking available.

Please consult our website for additional information and details.

2. Each exhibitor packet will include a hangtag for exhibitor parking in a lot on the show site. This hangtag is good for the day your dog is being shown ONLY.

## **JUDGING**

1. The conformation judging starts promptly; no exception for tardiness. During the hours of judging exhibitors are to be on call and have their dogs ready to bring into the ring promptly.



2. The owner of the dog or the handler is responsible for the presence of their dog in the judging ring. There is no rule of this Club or the American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring.
3. **All cell phones, etc. must be on “mute” or “vibrate” when in or near the ring area. Persons with ringing or toning cell phones, etc. will be escorted from the ring area. No cell phone photos/videos are permitted.**
4. **The following breeds must be judged on a ramp** through all levels of conformation competition: Clumber Spaniels, Sussex Spaniels, Basset Hounds, Cirnechi dell'Etna, Kerry Blue Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows & Keeshonden. Breeds designated as ramp optional may, at the discretion of the judge, be judged on a ramp through all levels of competition. The full policy and list of Table and Ramp eligible/required breeds is available on the AKC website at:

Judges may request the ramp to judge any breed in emergency situations; if granted, unless the use of a ramp has been indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. Junior Showmanship judges should follow the above.

**NOTE:** At this Show, all ramp optional breeds will also be judged on the ramp during Groups/BIS.

5. **WRISTBANDS:** BOB/V winners (and one assistant) will receive a BOB/V wristband for the day they win BOB/V, for access to the Ready Ring that evening. The band must be worn for access to the Ready Ring and the Groups. These bands are **ONLY** for the handler and one assistant of the BOB/V winning dog. All others must sit in the Exhibitor Section for Groups, or in a purchased ticket seat. The Ready Ring area is for BOB/V dogs and their handler/assistant **ONLY**.

## LOSS OR DAMAGE

1. The WKC, the Superintendent and site management will not be responsible for the loss or damage to any dog or property of any exhibitor, whether the result of accident or any other cause. It is expressly understood that every dog at the show is in the care and custody and control of its owner or handler during the time the dog is on the show premises. See also the Agreement on Premium List pages 5 & 6 and on the reverse of the entry form.
2. The welfare of an exhibitor's/spectator's child is the responsibility of the exhibitor/spectator. It is expressly understood that exhibitors/spectators will exercise control and restraint over their children while they are on the show premises. The use of child strollers is NOT recommended.
3. The Westminster Kennel Club and its Superintendent caution all persons entering the show site and show grounds against all hazards which may exist, including, but not limited to: Condition of the site/grounds, parking/loading/unloading areas, entrances, floors and stairways, elevators and escalators, floor coverings, walkways, tenting/canopies, electrical appliances, cords and fittings, exercise pens, and the presence of animals. All persons should take into consideration this is a sporting event and dress, act and exercise caution appropriate for the activity involved. All persons entering the show, the grounds, site and show areas for whatever purpose do so entirely at their own risk. By virtue of entering the show, the entrant has indicated their acceptance of the terms listed in this premium list and assumes all risks involved.
4. No entry fees are returned if the show cannot open or be completed by reason of riots, wars, civil disturbances, national emergencies, health emergencies, extreme weather conditions, fire, an act of God, public emergency, act of a public enemy, strikes, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or any other cause beyond the control of The Westminster Kennel Club, nor shall USTA Billie Jean King National Tennis Center or the Superintendent be liable in any way. The well-being of dogs, exhibitors and spectators is of

## **EQUIPMENT**

1. The Club and its Superintendent provide assistance to exhibitors and handlers in unloading and placing their crates and grooming tables. By entering this show, exhibitors and handlers agree to follow all directions of WKC personnel charged with arranging and maintaining orderly conditions in the grooming areas. Abuse of WKC personnel will not be tolerated. See Premium List pages 5, 6, 12-14 & 35-41.
2. **All daytime grooming will take place in the grooming tents. Grooming of dogs in areas other than those specified is not permitted. All crates/tack units must be stacked. Exhibitors are expected to keep their grooming area clean. Exhibitors who set up in the grooming tents should remove their equipment promptly after exhibiting unless dog is required for Group Judging. See Premium List pages 5, 6, 12-14, 35-41.**
3. **No flexi/retractable leads or stacking trainer equipment is permitted at this show.**
4. **Fabric crates are not permitted at this show.**
5. **Public exercise pens will be for multiple dogs at all times. Dogs must be on a lead in exercise pens. No exceptions. A separate area will be provided for bitches in season. Owners/handlers are to clean-up after their dogs. Blocking off exercise pens is NOT permitted.**
6. **For the safety of all, no other tables and other furniture are allowed in the ring areas. No aisle obstruction is permitted.**
7. Handbills, circulars, or other printed matter may not be distributed at this show.
8. No gasoline or diesel powered generators are permitted. Power for exhibitors will be provided in the grooming tents. All cords must be secured to avoid tripping hazards.

9. Neither WKC, USTA Billie Jean King National Tennis Center nor the Superintendent is responsible for any equipment or supplies or other belongings left on the the show site.

## **AGREEMENT**

1.
