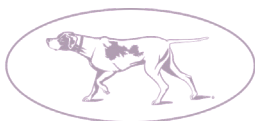

TRANSFERS by Junior Handlers to a different Ring or a different day should be done prior to the start of the first Junior Limited Class on Monday. SUBSTITUTIONS of Junior Showmanship dogs must be made prior to the judging of the class at the show.

Juniors who substitute for the original dog they have entered in the Junior Showmanship Class with dogs that are not entered in one of the offered classes at this show will not incur an additional fee.

4. The Westminster Kennel Club reserves the right to broadcast or cause to be broadcast any or all portions of The Westminster Kennel Club Dog show by any means of known transmission of video material.

MISCONDUCT

In order to expedite the Event Committee's handling of Incidents or Charges of Conduct Prejudicial to the Sport, the Committee requests, if possible, that charges be received in writing at the Show site within one hour of the incident so they may be investigated & resolved, if possible, on the same day.

STATE LAWS

The New York State Health Code requires all animals to be accompanied by a Current Rabies Vaccination Certificate issued by a licensed Veterinarian. Additionally all dogs residing in New York City must have a valid dog license.

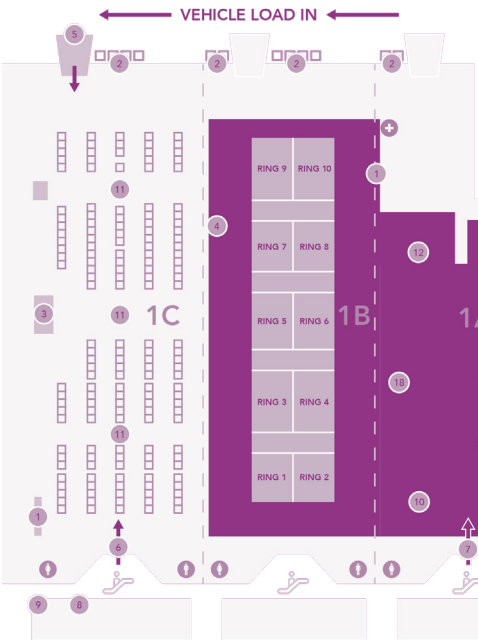
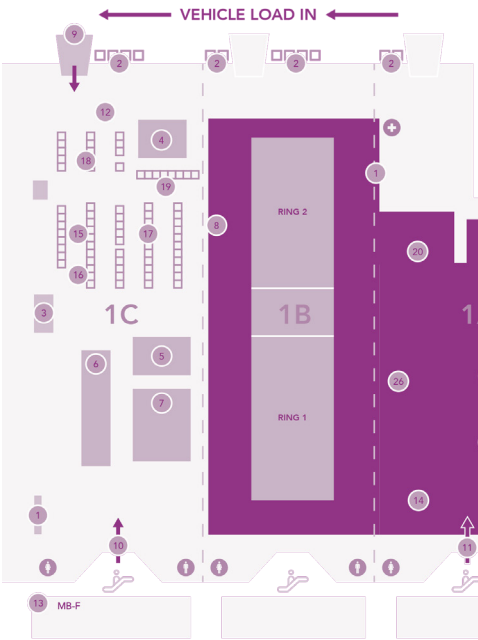

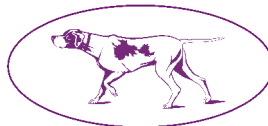

**ENTERING THE JACOB K. JAVITS
CONVENTION CENTER**

All dogs/exhibitors must be on their benches in Hall 1C by 11 a.m. on the day your dog is being shown. We encourage exhibitors to arrive at the site and bring their crates/supplies the day before you show.

- ☐ **Monday exhibitors** can begin to arrive at Javits to set up from 3 p.m. to Midnight on Sunday, February 9, 2025.
 - ☐ Monday dogs can be left at Javits Sunday night for Monday judging. Tuesday dogs can be left at Javits Monday night for Tuesday judging. Please see the required form and additional information, regarding this option. A signed release form and crate identification tag will also be required.
 - ☐ **All Monday dogs except for two-day multi breed handlers must be removed from the benching area by 6 p.m. on Monday**, so Tuesday dogs can move in.
- ☐ **Tuesday exhibitors** can arrive at Javits to set up from 7 p.m. to Midnight on Monday, February 10, 2025.
 - ☐ All dogs must be out of the benching area on Tuesday night by 1 a.m. (no exceptions).
- ☐ Please follow the entry instructions below and proceed to your benching location designated in your exhibitor packet.

MB-F, Site Control, Security, and WKC personnel will be on hand to assist you in the process as needed.

Exhibitors with private vehicles

- ❑ You may enter the loading dock area at W. 40th Street and 12th Avenue beginning at 6 a.m. on Monday and Tuesday
- ❑ Your exhibitor packet will include a Westminster day-specific hangtag with the QR code for exact Google directions (369 12th Ave., NY, NY) to the loading dock entry area.
This hangtag must be displayed on your rearview mirror to enter the loading dock. Please remember to add your cell number to this hangtag.
- ❑ The loading dock has a loop where cars will wait their turn to pull up to the loading area. You will then be directed to the benching area in Hall 1C
- ❑ We request that one person exit the car with the dog and equipment and proceed to the benching area. Site Control personnel will be on hand to assist as needed. MB-F superintendents will also be available for any entry assistance needed. Please follow the instructions of Javits security, Site Control, and WKC personnel who will direct you to an unloading spot
- ❑ Please have wristbands secured to your wrists before exiting the car. If you have additional people in your vehicle, please make sure they prepurchase daytime admittance tickets for the day your dog is entered
- ❑ At 4 p.m. each day, cars will be permitted to return to the loading dock at W. 40th Street and 12th Avenue to line up for exiting. Exhibitors will line up to await the release of exhibitors and dogs. Please follow the directions of WKC personnel, security, and Site Control personnel and **do not begin lining up until directed to do so**

Shuttle buses from The New Yorker AND Ride Share vehicles

- ❑ The shuttle buses are offered as a courtesy by WKC from The New Yorker Hotel/Javits/MSG. Hotel Shuttle Stop is located at the NW corner of W. 34th St. and 8th Ave.
You also have the option of private transportation.
- ❑ Guests from other hotels or the train are permitted to ride the buses, but exhibitors with dogs have priority

RULES AND PROCEDURES

EXHIBITOR TICKET INFORMATION

1. **Regardless** of the ownership of the dog(s) two (2) exhibitor's wristbands, good for daytime admittance to the site, including the ready ring area on the day your dog is entered will be mailed to you in your exhibitor packet. The person accompanying the dog must wear the wristband when entering the show and also have the dog identification before the dog will be admitted. **DO NOT BRING ANY DOGS THAT ARE NOT ENTERED.** There is no provision for unentered dogs at this show. **Exhibitors must preserve their dog identifications which are required to be handed in to a guard in order to remove the dog from the show site. (See also Premium List pages 5-7, 21-47.) Wristbands must be securely affixed to your wrist prior to entry.**
2. The daytime wristbands will take the place of paper or electronic tickets and will be sent to the address noted on the entry form. Owners or the owners' duly authorized agent are responsible for the correctness of their mailing address. **No duplicate packets are mailed.** See page Premium List page 14, item #9 regarding the Mail/Hold for pick-up Options, including Foreign. Also see Premium List pages 8, 21, 27, 33 regarding address changes.
3. Regular exhibitor packets returned by the Post Office marked "Undeliverable" are held at the show at the Superintendent's Office.
4. **NOTE: Juniors receive an exhibitor admission wristband for each day plus two guardian wristbands per entry for all show days. Misuse of the Junior wristband could result in an Event Committee Hearing.**
5. **If additional Admission tickets are needed please visit our website for information.**

JUDGING

1. The conformation judging starts promptly; no exception for tardiness. During the hours of judging exhibitors are to be on call and have their dogs ready to bring into the ring promptly.
2. The owner of the dog or the handler is responsible for the presence of their dog in the judging ring. There is no rule of this Club or the American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring.

3. **All cell phones, etc. must be on “mute” or “vibrate” when in or near the ring area. Persons with ringing or toning cell phones, etc. will be escorted from the ring area. No cell phone photos/videos are permitted.**
4. **The following breeds must be judged on a ramp** through all levels of conformation competition: Lagotti Romagnoli, Clumber Spaniels, Sussex Spaniels, Basset Hounds, Cirnecchi dell'Etna, Kerry Blue Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows & Keeshonden. Breeds designated as ramp optional may, at the discretion of the judge, be judged on a ramp through all levels of competition. The full policy and list of Table and Ramp eligible/required breeds is available on the AKC website at:

Judges may request the ramp to judge any breed in emergency situations; if granted, unless the use of a ramp has been indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. Junior Showmanship judges should follow the above.

NOTE: At this Show, all ramp optional breeds will also be judged on the ramp during Groups/BIS.

5. **BOB/V WINNERS:** The BOB/V winner's award envelope handed out in the ring will contain 4 MSG access credentials for admittance to the benching area and 2 tickets for the General Admission Seating Section for Groups. The credentials must be worn for access. They are good only for the day they are judged in the Groups. If additional tickets are needed they must be purchased through Ticketmaster. The Ready Ring area is for BOB/V dogs and their handler/assistant **ONLY**.

LOSS OR DAMAGE

1. The WKC, the Superintendent and site management will not be responsible for the loss or damage to any dog or property of any exhibitor, whether the result of accident or any other cause. It is expressly understood that every dog at the show is in the care and custody and control of its owner or handler during the time the dog is on the show premises. See also the Agreements on pages 4 & 5 and on the reverse of the entry form.

2. The welfare of an exhibitor's/spectator's child is the responsibility of the exhibitor/spectator. It is expressly understood that exhibitors/spectators will exercise control and restraint over their children while they are on the show premises. The use of child strollers is NOT recommended.
3. The Westminster Kennel Club and its Superintendent caution all persons entering the show site and show grounds against all hazards which may exist, including, but not limited to: Condition of the site/grounds, parking/loading/unloading areas, entrances, floors and stairways, elevators and escalators, floor coverings, walkways, tenting/canopies, electrical appliances, cords and fittings, exercise pens, and the presence of animals. All persons should take into consideration this is a sporting event and dress, act and exercise caution appropriate for the activity involved. All persons entering the show, the grounds, site, ring, and show areas for whatever purpose do so entirely at their own risk. By virtue of entering the show, the entrant has indicated their acceptance of the terms listed in the premium list, on the entry form and this judging program and assumes all risks involved.
4. No entry fees are returned if the show cannot open or be completed by reason of riots, wars, civil disturbances, national emergencies, health emergencies, extreme weather conditions, fire, an act of God, public emergency, act of a public enemy, strikes, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or any other cause beyond the control of The Westminster Kennel Club, nor shall NYCCOC, Madison Square Garden or the Superintendent be liable in any way. The well-being of dogs, exhibitors and spectators is of paramount importance and in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made. EQUIPMENT

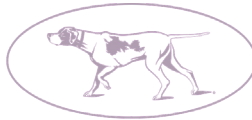
1. The Club and its Superintendent provide assistance to exhibitors and handlers in unloading and placing their crates and grooming tables in the benching area. By entering this show, exhibitors and handlers agree to follow all directions of the special assistants charged

with arranging and maintaining orderly conditions in all show areas. Abuse of these assistants will not be tolerated. See Premium List pages 5-8, 21-47.

2. **ALL Grooming will take place at the dog's bench in each of the show venues. Grooming of dogs in areas other than those specified is not permitted. All crates/tack units must be stacked. Exhibitors are expected to keep their grooming area clean. Grooming tables in excess of 24 x 48 inches are not permitted at Javits. Tables must be folded when not in use. Benching/Grooming of dogs in areas other than those specified is not permitted. All crates/tack units must be stacked. See Premium List pages 4, 5-8, 21-47.**

Grooming tables will be provided by the Club for the BOB/V Winners at MSG. These tables are the property of The Westminster Kennel Club and may not be removed from the show site. See also Premium List pages 44-46.

3. **No Flexi/retractable leads or stacking trainer equipment permitted at this show.**
4. **Fabric crates are not permitted at this show. All crated dogs must be in crates that permit the public to easily view the dog.**
5. **No private exercise pens are allowed anywhere in each of the venues. Public exercise pens will be for multiple dogs at all times. Dogs must be on lead in exercise pens. No exceptions. Separate ex-pens will be provided for bitches in season. Owners/handlers are to clean-up after their dogs. Blocking off exercise pens is NOT permitted.**
6. **A small chair may be placed between bench and grooming table. For the safety of all, no other tables or furniture are allowed in the benching areas. No aisle obstruction is permitted.**
7. **Handbills, circulars, or other printed matter may not be distributed at this show.**
8. **No gasoline or diesel powered generators are permitted. Power for exhibitors will be provided at the benches. All floor cords must be secured to avoid tripping hazards.**
9. **Neither WKC, NYCCOC, Madison Square Garden, nor the Superintendent is responsible for any equipment or supplies or other belongings left on the show sites.**
