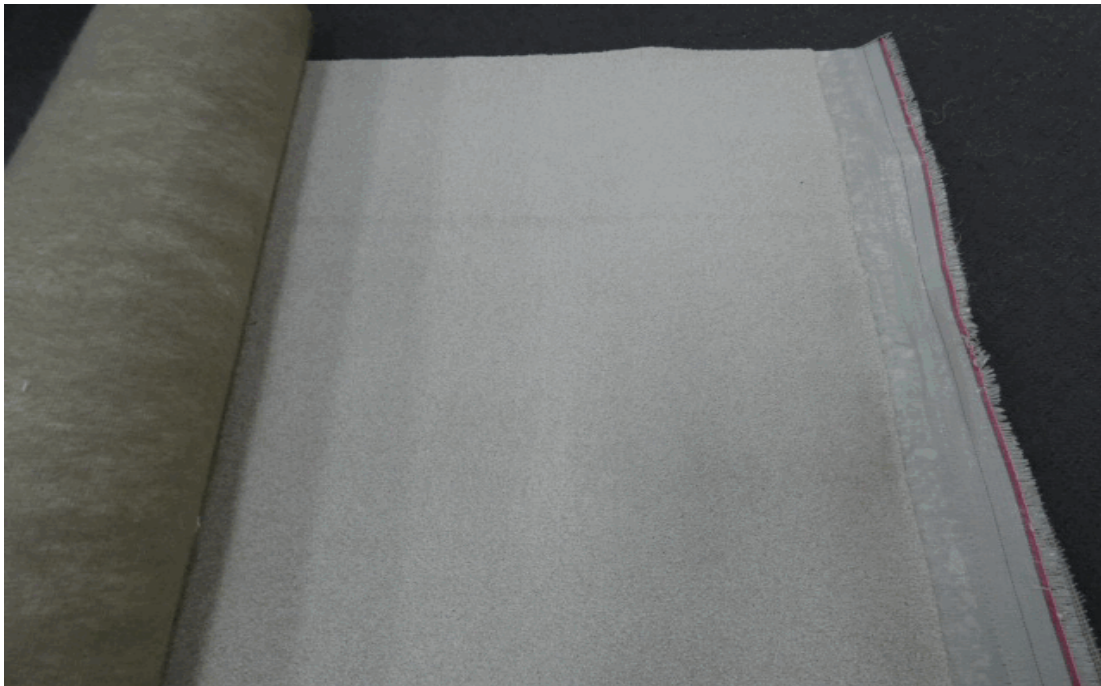

Each specimen was adhered to Dunlop - Durafit 7 underlay using RLA - R656 adhesive and then bonded to 6mm thick fibre reinforced cement board using RLA - R656 adhesive and clamped prior to testing.
