Located on the northeast corner of Highway 16 & Highway 21, in the planned community of Bremner, the sites are designated for low and medium density development. The Parcel presents a truly rare opportunity to acquire a prime, near-to-mid term development site of scale in one of the regions strongest growth nodes.

- Located within the Bremner and Local Employment Area (LEA) Area Concept Plan (ACP)
- The Parcel is within an Area Structure Plan (ASP) that has recently been commissioned for the southwesterly ~1,200 acres of the Bremner ACP (Est. completion in 2023)

- The Parcel borders both the Yellowhead Highway (Highway 16) and Highway 21 providing future residents with quick and easy access to the significant surrounding employment hubs in Edmonton, Sherwood Park, Fort Saskatchewan and Alberta's Industrial Heartland
- Immediate access to existing services and amenities in Sherwood Park with easy access to the Anthony Henday ring road

The Parcel is being offered to market on an unpriced basis with offers being evaluated as they are received.





PROPERTY OVERVIEW

Located within the planned community of Bremner, the Parcel, as set forth in the Bremner and Local Employment Area (LEA) Area Concept Plan (ACP), is to be developed into a future residential subdivision. The Area Concept Plan was approved in 2019 and covers the entire Bremner area.

The plan is a statutory guide that pilots the way for smaller scale Area Structure Plans (ASPs). ASPs for Bremner Community 1 and 4 were both approved in 2021. The Parcel enjoys an attractive position within a new ASP that has recently been commissioned for the southwesterly ~1,200 acres of the Bremner ACP.


BREMNER COMMUNITY PENDING ASP


LOCATION OVERVIEW

- Bremner is a continuous expansion of Sherwood Park east of Highway 21. The Local Employment Area (LEA) is located across from Bremner, on the southside of Highway 16. Highway 16 turns into Yellowhead Trail to the west providing access to Edmonton. Highway 21 provides access to the City of Camrose to the south and access to the Hamlet of Sherwood Park and the City of Fort Saskatchewan to the north.
- The immediate proximity to the regional transportation network provides convenient access to Sherwood Park, Downtown Edmonton, the International Aiport and key regional facilities by utilizing the Anthony Henday ring road.
- Sanitary sewer and water services are to be extended from the Cambrian Lands to the west, from Township Road 534 and across Highway 21, approximately 1.5 miles north of the subject. Power and Gas are readily available.
