Meadow Industrial currently has 2 different zoning designations, M-3 for the parcel of land located at 8335 Meadow Avenue and M-3a for the parcel located at 6064 Spur Road. Both are rare and sought-after heavy industrial zonings that allow for a wide range of industrial uses not allowable under most other industrial or business classifications, including container storage on the Spur Road site.
