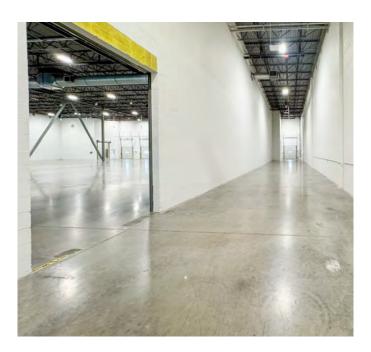

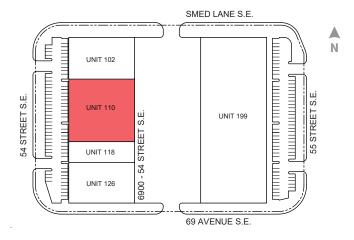

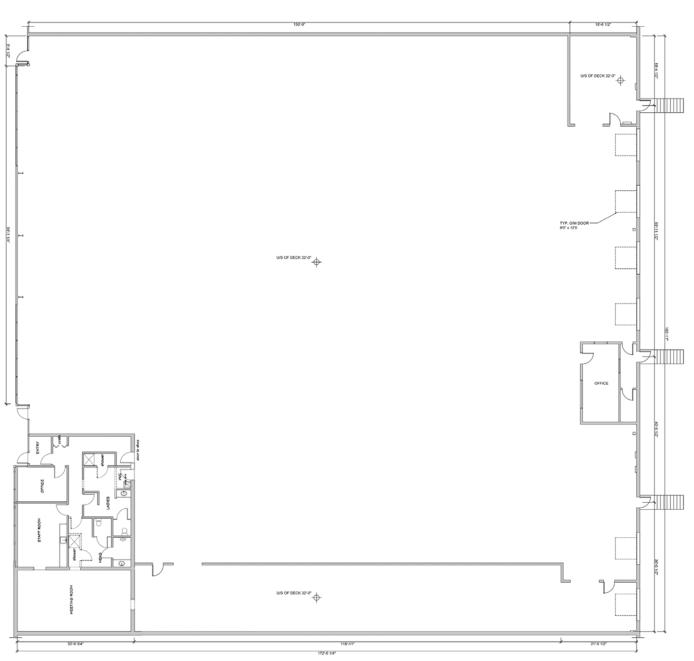






Floor Plan
