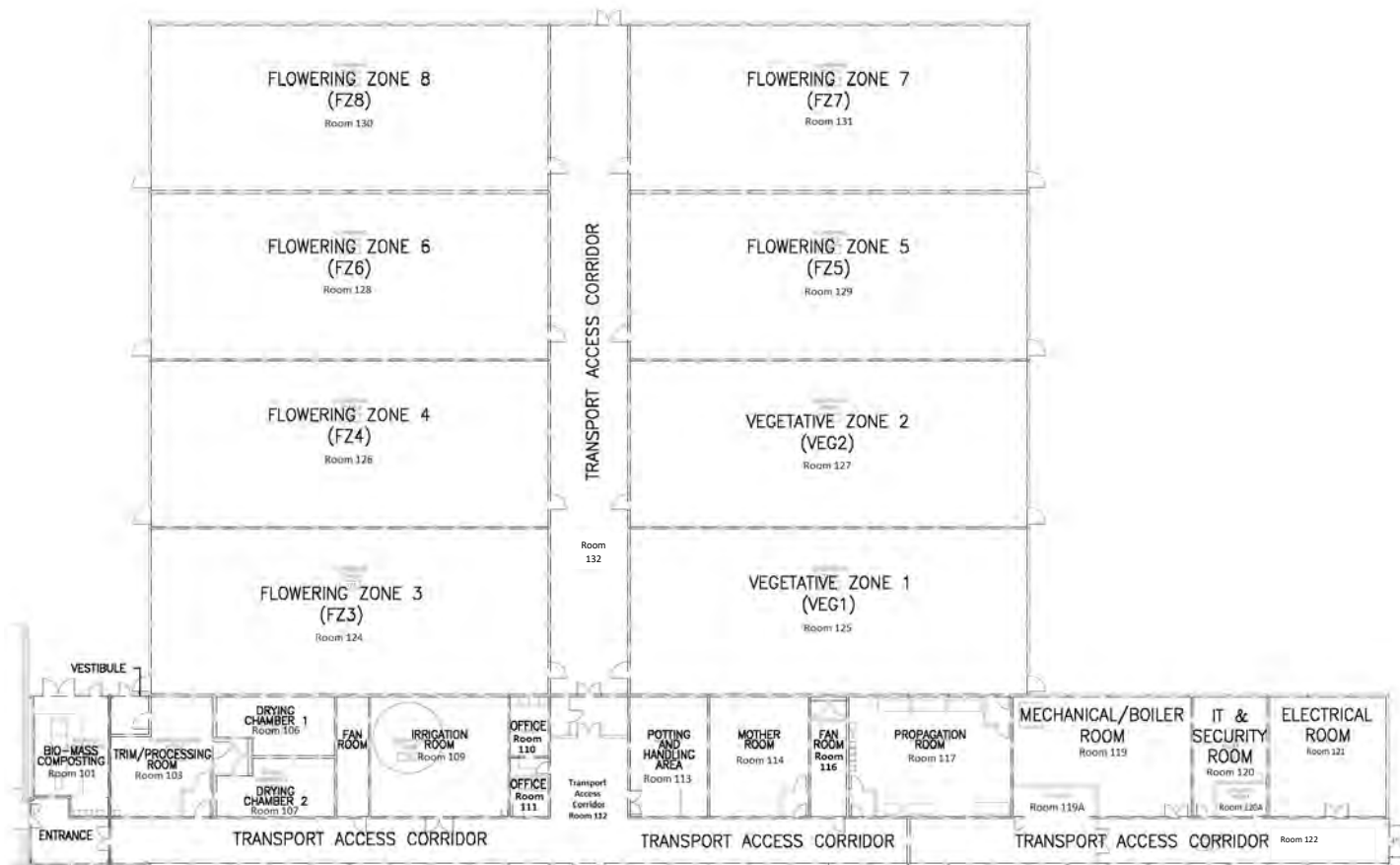
South Building
