We, **Globus Group** hereby declare that the packaging associated with the product listed in the table, including the transit packaging, complies with the applicable requirements set out in the EU Packaging and Packaging Waste Regulation (EU) 2025/40 (PPWR) and other relevant EU legislation.

- We comply with applicable requirements relating to heavy metals and other restricted substances
- The sum of the concentrations of Lead (Pb), Cadmium (Cd), Mercury (Hg) and Hexavalent chromium (Cr (VI)) resulting from substances present in packaging or packaging components does not exceed 100 mg/kg
- Our packaging is designed to minimise the amount of material used while maintaining functionality, product protection, and is designed for recyclability in line with the applicable PPWR requirements and implementation timelines
- We support reusable transport packaging systems where applicable and support circular economy principles within the supply chain
