



## **Charitable Giving and Corporate Support Program**

San Miguel Electric Cooperative, Inc. is a not-for-profit, member-owned corporation and it is our mission to “Maintain a dependable power supply at the lowest possible and competitive cost to our customers through integrity, hard work, and safety.”

We strive to actively support various qualifying organizations within the geographic areas of San Miguel. For this reason, San Miguel can donate up to a \$1,000 charitable donation on an annual basis to a qualifying organization that is located within the geographic areas of San Miguel, Atascosa and McMullen Counties of Texas.

To qualify for a charitable donation from San Miguel an organization must meet the following qualifications:

- Be located within Atascosa and McMullen Counties of Texas.
- Be a 501(c)(3) nonprofit organization, a 501(c)(4) social welfare organization, or a 501(c)(6) business league.
- Be able to provide a copy of their 501(c) tax certificate and tax identification number.

San Miguel is unable to provide charitable support to an organization for any of the following reasons:

- The organization discriminates based on age, sex, race, religion, national origin, or disability.
- Charitable requests from religious organizations. However, community programs that are sponsored by religious organizations will be considered.
- Requests from or for local, regional, and/or school-based sports teams, extracurricular teams or clubs.
- Requests that solicit financial support for individuals, political candidates or campaigns, or entities that are not Qualifying Organizations.
- Requests for school trips, athletic or other extracurricular events or trips, or recreational trips or tours.
- Requests for sponsorship for individuals in beauty pageants, livestock shows, or scholarship drives, or any other requests for funds for an individual.
- Any request for financial support for an organization that is located outside of Atascosa and McMullen Counties of Texas.
