

- Draft considerations under review







Hamilton County

Commissioners

- Children's Services Levy
- November 2, 2021 ballot
- Currently 4.75 mill total
- 2.77 mill + 1.98 mill
- Decision by end of June

Cincinnati & Hamilton County Public Library

- Two 1.0 mill levies
- 2014-2023, 2019-2027
- 2020 tax revenue
- 2020 state funding
- 2020 total revenue
- 95% public funding
- \$39.2 million \$41.4 million \$84.5 million



Levy Funding Scenarios

Included Costs (beginning in 2022):

- Increased funding for staffing including new FT staff & additional PT hours
- 3% annual operating increase
- 1% annual earned revenue increase
- Assumes replacement of existing 1.00 mill levy in 2026

* Total Funds Needed includes 75% of philanthropic capital campaign pledges received in 10 years

- Majority of pledged dollars anticipated to be received in the final 3-5 years of campaign
- Estimated total pledges received is \$37,500,000
