District Honored for Outstanding Public Drinking Water System

Trophy Club Municipal Utility District No. 1 (District), which provides water and wastewater services to the Town of Trophy Club and parts of Solana located in the Town of Westlake, has been awarded the Outstanding Public Drinking Water System Award by the Texas Commission on Environmental Quality (TCEQ).

TCEQ presented the award at the Public Drinking Water Conference in Austin on August 9, 2022.

The honor recognizes overall excellence in all aspects of operating a public water system (PWS). To be recognized, a PWS must go above and beyond the minimum standards in protecting public health and ensuring reliable operation.

"This commendation is appropriate to all individuals who have served this District and this community," said District General Manager Alan Fourmentin. "This award is a testament to the years of planning and funding efforts of current and prior Board of Directors members, and operational efforts of current and prior staff."

How did the District go above and beyond? It was required to meet the following criteria to be considered for the Outstanding Public Drinking Water System Award:

1. Meet the criteria for being recognized as a superior PWS, as established by rule in Title 30, Texas Administrative Code, Subsection 290.47(a), Appendix A. The District achieved the status as a superior public water system in 2013.

2. Exceed the capacity requirements for production, total storage, service pump capacity and pressure maintenance.

- The system's production capacity is 9,173 gallons per minute, far surpassing the 2,832 gallons per minute required for its 4,720 connections.
- A total storage capacity of 200 gallons per connection equates to 944,000 gallons. The District has secured 6.9 million gallons of total storage capacity.
- Finally, the system must be designed to maintain a minimum pressure of 35 psi at all points within the distribution network at flow rates of at least 1.5 gallons per minute per connection. The District meets this requirement even during maximum daytime demand periods.

3. Promote year-round water conservation. The District prepares plans for drought contingency

and year-round water conservation. The Town of Trophy Club adopts those plans, which include public involvement and education, coordination with regional water planning groups, criteria for drought and emergency response stages, and notification systems.

4. Implement a source water protection program.

The District receives most of its source water – approximately 80 percent – from the City of Fort Worth, which owns the responsibility of protecting water sources. The District also implements a source water protection program for its groundwater supply.

5. Have no violations of the primary drinking water

standards, no enforcement action(s), unresolved violation(s) from the Water Supply Division, from the Office of Compliance and Enforcement, and from the U.S. EPA within the last three years. The District has incurred none of the listed violations within the last three years.

6. Have a cross-connection control program.

The District uses a third-party organization called SC Tracking Solutions to help implement a cross-connection control program.
