When coaching outside of PCA organised events it is the responsibility of you as a Coach to ensure that your students are current Financial Riding Members of PCA and that you keep a record of their accreditation on file. In the event of a claim, the onus will be on you to provide evidence that your client is indeed a current Financial Riding Member. It is important to note that no cover is provided under this policy for coaching individuals who are not current Financial Riding Members of PCA. 	If insurers accept a valid claim under Part A, Capital Benefits, or Part B, Weekly Injury Benefit, insurers agree to pay actual rehabilitation expenses incurred, such as but not limited to gymnasium or fitness centre fees, or personal physical trainer fees, or the like, as certified necessary by the insured person's treating medical specialist.

	If an insured person sustains a bodily injury and an income earning carer of that insured person is unable to earn their income due to the ongoing caring of the insured person, insurers shall pay 85% of the carer's income whilst they continue to care for the insured person.
	The maximum insurers shall pay is \$500 per week, whilst the insured person continues to require care relating directly to the bodily injury, up to a max of \$5,000. Insurers shall not pay for the first 28 days of care, and all payments will cease upon the insured person's medical specialist noting care is no longer required.

Student Help	\$500 per week maximum for a maximum of 52 weeks

#### In The Event Of A Claim

If you are claiming for weekly benefits please supply the following:

- Proof of earnings
- Supporting Medical Certificates

If you are claiming for Non-Medicare Medical Expenses the following apply:

- The expenses must be incurred within 12 months from the date of the injury.
- \$50 excess applies to each and every claim unless you are part of a Private Health Fund.
- <u>No expenses claimable under Medicare are</u> covered by this insurance, including the <u>Medicare gap.</u>
- It is mandatory to submit your expenses through your Private Health Insurance Fund first before submitting to Gow-Gates.
