Section 5. Fire-fighting measures

Suitable fire extinguishing media : Use dry chemical, CO₂, water spray (fog) or foam.

Specific hazards arising from the chemical : Combustible liquid. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. Runoff to sewer may create fire or explosion hazard. This material is toxic to aquatic life. Fire water contaminated with this material must be contained and prevented from being discharged to any waterway, sewer or drain.

Specific fire-fighting methods : Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. Methods for cleaning up : Follow company's spill procedures. Keep people away from spill. Put on appropriate personal protective equipment (see section 8). Absorb/neutralize liquid material. Use a tool to scoop up solid or absorbed material and put into appropriate labeled container. If emergency personnel are not present, contain and collect small spillages with non-combustible absorbent material, e.g. sand, earth or other suitable material and place in a suitable container for disposal. Use a tool to scoop up solid or absorbed material and place into appropriate labeled waste container. Use a water rinse for final clean-up.
