






BREEO X SERIES® FIRE PIT COVER INSTRUCTIONS







ADDED PROTECTION

The Breeo X Series Fire Pit Cover, made with water-resistant fabric, is designed to add an extra layer of protection to your fire pit. Keep your fire pit clean and prevent debris from gathering inside your fire pit. For best results, pair with the X Series Lid.

USE WITH FIRE PIT

STEP 1

Wait until your Breeo® fire pit is completely cool before putting the Breeo fire pit cover on.

STEP 2

Pull the cover down over the sides of the fire pit as far as possible.

STEP 3

Make sure that the cord section of the cover is down around the rim of the fire pit.

STEP 4

Pull the drawstring cord tight around the bottom of the fire pit rim.

USE & CARE

While the Breeo fire pit cover is designed to be easy to maintain, proper care and cleaning are important to the life of all fabrics. Retreating the fabric annually with products such as 303° or NeverWet® to restore water repellency is recommended (but not required) to yield best performance.

CLEANING YOUR COVER

Add 2 ounces of mild soap dishwashing liquid to 1 gallon of lukewarm water. Clean the fabric with a soft bristle brush. Rinse thoroughly with cold water and air dry.

! WARNING

To avoid any damage to your fire pit cover, we recommend waiting until your fire is out and the Breeo® fire pit is completely cool before putting on the fire pit cover to avoid any melting or damage to the fabric.

This fire pit cover is designed for outdoor use only.

Except as provided above, no warranty is offered on rust, paint or finishes due to being made with material with potential for corrosion. Steel products will develop a natural iron oxide patina over time.

Breeo, LLC's liability and obligation is limited to repair or replacement of the product, at their option. The purchaser must provide Breeo, LLC with photos of the product's defects for evaluation. Upon approval of warranty, Breeo, LLC will issue a return for repair, or return for exchange of the defective product.

This warranty does not cover damage or product failure caused by normal wear and tear, accident, misuse, negligence, tampering, modifications, act of war, overloading, improper attachment, improper maintenance, or failure to maintain. Breeo, LLC is held harmless for any injury or death caused by the misuse of this product.
