KETTLE CARE INSTRUCTIONS



STEP 1

Clean the kettle by washing it by hand with water and a small amount of soap. If food is stuck to the kettle, simmer a small amount of water for 3-5 minutes, and use a scraper after the pan has cooled.



STEP 2

Dry promptly by reheating the kettle until the moisture evaporates, or use a lint-free cloth or paper towel to wipe dry.



STEP 3

Rub a light layer of cooking oil or spray on the surface of the kettle. Use a paper towel to wipe the surface until there is no oil residue left.



Scan to check out live-fire recipes using the Kettle.

Our cast iron kettle arrives pre-seasoned and ready to use! Just give it a quick rinse, dry, and fire it up!

FOR YOUR SAFETY

Always wear gloves when interacting with the kettle over an open fire to avoid burns.

Hand wash only.

Do not use steel wool or a metal scrubber to clean your kettle.

Do not soak your kettle as leaving water in it may cause it to rust.

When paired with the kettle hook or Outpost™ grill, do not overfill. Do not exceed 20lbs. of weight on the 19in. kettle hook or grill, or 40lbs of weight on the 24in. kettle hook or grill.

The cast iron kettle allows you to level up your live-fire cooking game with a durable, pure cast iron kettle. Available in three different sizes, each size is made to fit your needs, weighing from 13.71 to 21.78 pounds. The intentional design, durability, and compatibility with Breeo® grilling accessories allow for maximum efficiency and lasting enjoyment.
