GRADING CRITERIA

Rustic grade, also known as natural grade, allows a virtually limitless size and number of knots. Heartwood will be used, there will be colour variation, sapwood and filler. You should expect checks (cracks across the growth ring) and possibly some end shake (cracks between the rings). The colour of the filler is carefully selected to compliment the wood rather than to match it exactly and it may vary from batch to batch.
