Our teacher registration programmes include:

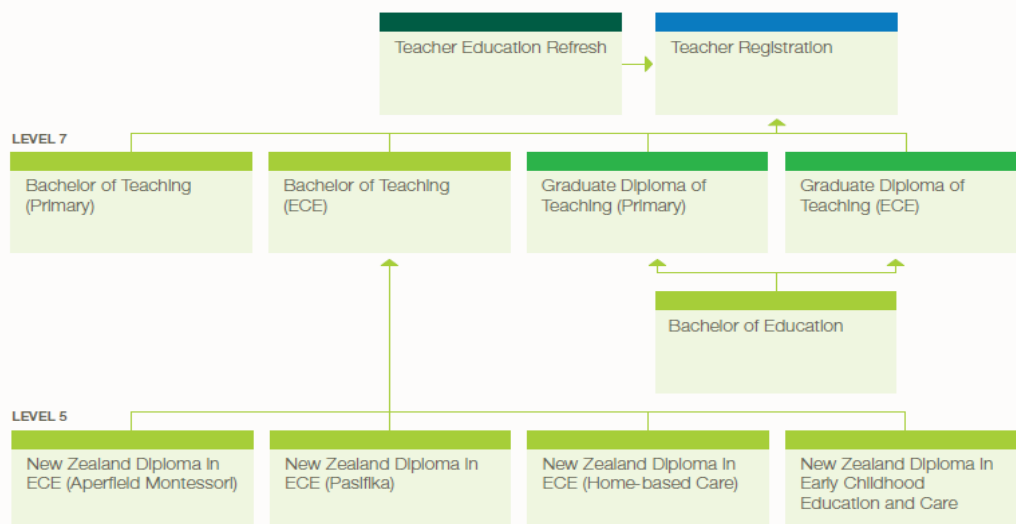
Bachelor of Teaching (ECE)- two intakes per year, Jan and July

Bachelor of Teaching (Primary)- one intake per year, Jan

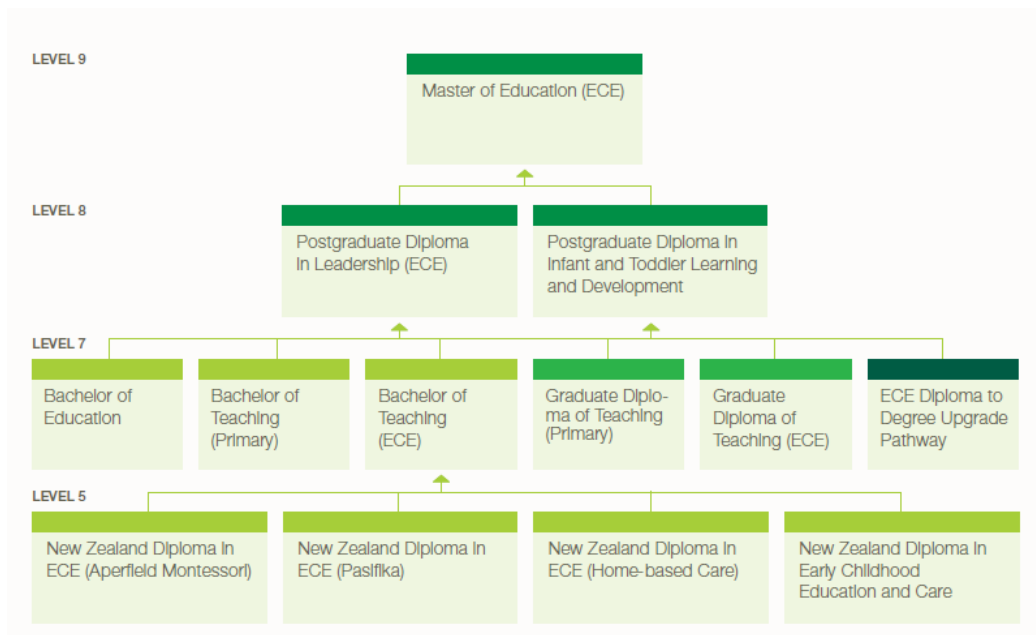
Graduate Diploma of Teaching (ECE)-two intakes per year, Jan and July
