# 1. Introduction/Eligibility

#### 4. How to Enter

No purchase necessary.

- i. Posting a picture of yourself and/or your current desk on Instagram, tagging and following "smartmovesdesk", and including the hashtags #mystupiddesk #ineedadesk #smartmovesdesks in your post or,
- ii. Posting a picture of yourself and/or your current desk on Facebook, tagging and following "SmartMoves Desk", and including the hashtags #mystupiddesk #ineedadesk #smartmovesdesks in your post.

Each Participant must be a natural person, and each Participant is limited to a single email address, Facebook account, and/or other accounts used for entry. Multiple Participants are not permitted to share the same email address, Facebook account, and/or other accounts used for entry. Any incorrect or incomplete entry is void.

Any attempt by any Participant to obtain entries by using multiple/different email addresses, Facebook and other social media accounts, identities, registrations or logins, or any other methods will void that Participant's entries and that Participant will be disqualified from the Promotion.

All costs, taxes, fees, and expenses associated with any element of the prize not specifically addressed above are the sole responsibility of the respective Winner.
