#### PROCESS DESCRIPTION

- · High Pressure Laminate or Melamine is adhered to particleboard using PVA.
- · PVC edgebanding is adhered to edges where required.
- · Vinyl covered particleboard drawer boxes are assembled and glued using white glue and hot melt adhesive.
- · Components are assembled using mechanical fasteners.
- · Unit is placed in a corrugated packaging for shipment to end user.
