PROCESS DESCRIPTION

- · Pre-painted steel tubes, zinc die-cast ends and aluminum components are press fit and secured with spring steel clips to create the frame.
- · Fabric is attached to fiberglass and hexacomb assembly using adhesive.
- · Upholstered fiberboard and hexacomb is inserted into the frame.
- · Miscellaneous components are attached using mechanical fasteners.
- · Corrugated packaging top and bottom caps are added and units are stretch wrapped.
