This program may also be used with Not-For-Profit organizations including trade associations and charitable organizations. The Allsteel State and Local Government Sales Program is NOT for use with the United States government or with those specific organizations allowed to access the Allsteel GSA Contract.

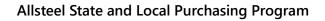
