Reconfiguration and Relocation Services: Available at a rate of \$78.00/hr. Agency must define the scope of services required, which will be negotiated with Special Representative (authorized dealer) on a project by project basis by the ordering activity involved. Additional charges may apply for: Weekends, Holidays and Overtime; Payment of Union Labor and /or Prevailing Wage. Additional charges may also apply for other extraordinary circumstances approved by the State of New Mexico Contracting Officer.

<u>Design/Layout</u>): Available at an hourly rate of \$71.00/hr. Billable design time and scope of services required will be negotiated with Special Representative (authorized dealer) on a project by project basis by the ordering activity involved. Additional charges may apply for: Weekends, Holidays and Overtime; Payment of Union Labor and/or Prevailing Wage. Additional charges may also apply for other extraordinary circumstances approved by the State of New Mexico Contracting Officer.

Installation: Not to Exceed \$100.00 hour; minimum charge of \$175.00 per order applies.
