DELIVERY

- **Standard Delivery**: Product is brought to the tailgate or end of truck and Purchasing Entity is responsible to unload.
- **Dock Delivery**: Product will be delivered and unloaded by a common carrier to a dock.
- **Inside Delivery:** Products will be delivered by the Authorized Dealer to the receiving address as designated on a purchase order. Products will be unloaded and unboxed by the Authorized Dealer with no installation required by the Authorized Dealer. Inside delivery must reflect a separte line item on the invoice.
 - o Inside delivery charges will be \$55 per hour.
- **Installation**: Products will be delivered, unloaded, uncrated, and install by the Authorized Dealer according to the plan and to a move in redy condition. Installation must reflect a separte line item on the invoice.
 - o Installation charges will be \$55 per hour.
- **Exception:** Contractor shall provide, through their Authorized Dealer network or approved freight carrier(s) liftgate services and other non-standard delivery services which are outside of Contractor's standard freight costs, such as palletization, storage, special permits, etc.; should Contractor be able to accommodate the request, these services will be negotiated on a project-by-project basis and approved by the purchasing entity. Charges for non-standard delivery services will be included as a line item in the quote provided by the Authorized Dealer.

SERVICES

- Quotes to the end user must reflect a separate line item for each service.
- Services shall be quoted following the guidelines below:

- o Design, including Reconfiguration and Layout Services \$65 per hour
- o Field Management \$75 per hour
- Project Management \$65 per hour

- » Orders MUST be sent to HON's Government Customer Service team by the following methods:

- » Orders under this contract may utilize federal funds. Dealers should review solicitations and orders for federal funding references, and if federal funds are utilized, notify Contractor prior to order placement.

ORDERS ARE PLACED THROUGH THE AUTHORIZED DEALER

Select Authorized Dealers have been approved by the State of Utah to receive purchase orders and payments; dealers must adhere to the following rules:
