#### **ELIGIBLE END-USERS**

- » Local governmental entities such as cities, counties, colleges, universities, and school boards in the State of Florida.
- » All Governmental Agencies which have a physical presence in Florida; any independent, nonprofit college or university that is in Florida and is accredited by the Southern Association of Colleges and Schools.
  - o Governmental Agency is defined as:
    - The State or any department, commission, agency, or other instrumentality thereof.
    - Any local government (county or municipality), or any department, commission, agency, or other instrumentality thereof.
    - Any school board or other special district, authority, or governmental entity.

#### **DELIVERY**

- » All orders must be delivered and installed within 60 days.
- » All orders are FOB Destination, company paid freight to one destination.
- » Charges for delivery are not approved under this contract and will not be accepted on an order. Orders that incorporate a line item charge that has "delivery" referenced will be returned to the dealer; the dealer will be required to correspond directly with the End User to remove these fees from the order.

#### **SERVICES**

- » **Installation**: Bidders have the option of offering installation, which may be at an additional cost represented by a percentage above the net price charged and may be charged at a percentage rate not to exceed 40%. Rates can be negotiated on a case by case basis when installation is required.
- » **Inside delivery** is intended for essentially free-standing furniture when the Authorized User is unable to bring it from the dock to the point of use. It shall consist of removal from truck, bringing to point of use, uncrating, minor assembly (for example: attach hutch to desk or credenza, attach a return, set shelves in bookcase and leveling), removal of packing/packaging debris and leaving ready for use. Inside delivery cannot be applied to installation, such as systems furniture, high density filing, and furniture shipped KD (Knocked Down). The Authorized User must specify at time of order, and prior to delivery, if inside delivery is required. Fee is not to exceed 25% and rates can be negotiated on a case-by-case basis when Inside Delivery is required.
- » Exception includes Non-Standard Installation will be a minimum of \$100 per hour with a not to exceed maximum charge of \$350 per hour. Non-Standard Business Hours Monday Friday, weekends, and holidays. Also includes, but is not limited to, long stair carry's, sites 60 miles over main dealer warehouse, prevailing wage, union labor and major metropolitan areas. Minimum of \$200 per order may apply. Additional fees will be agreed upon between buying agency and dealer/subcontractor.

Note: Design and Reconfiguration are not allowed.
