

Clayton Hotels Social Media Competition

Terms and Conditions

1. The Promoter

1.1 The promoter is Dalata Hotel Group plc, trading as Clayton Hotels, of Termini, 3 Arkle Road, Sandyford Business Park, Dublin 18, D18 C9C5 (“the Promoter”).

2. The Competition

2.1 This competition is in no way sponsored, endorsed, administered by, or associated with Instagram or Facebook (Meta Platforms, Inc.). By entering, entrants agree to a complete release of Instagram and Facebook from any liability in connection with this competition.

2.2 The competition will run from 00:00 on Monday 13 July 2026 to 23:59 on Sunday 19 July 2026 (“the Competition Period”). Entries received outside the Competition Period will not be considered.

3. Eligibility

3.1 The competition is open to residents of the Republic of Ireland and the United Kingdom aged 18 or over, except employees of Dalata Hotel Group, their immediate families, agents, or anyone else professionally connected with the competition.

3.2 No purchase is necessary to enter. Entry is free.

4. How to Enter

4.1 To enter, comment on the official competition post on the Clayton Hotels Instagram or Facebook page during the Competition Period.

4.2 One entry per person per platform. Entries made through agents, third parties, automated means, or multiple accounts will be disqualified.

4.3 The Promoter accepts no responsibility for entries that are lost, delayed, or not received for any reason.

5. The Prize

5.1 One winner will receive a one-night stay for two people, including breakfast, at any Clayton Hotel in Ireland or the United Kingdom (“the Prize”).

5.2 The Prize is subject to availability and must be redeemed within 12 months of the winner being notified. Blackout dates may apply, including bank holiday weekends and peak periods.

5.3 The Prize is non-transferable and non-exchangeable, and no cash alternative will be offered. All costs not expressly stated as included, such as travel to and from the hotel, additional meals, and incidental expenses, are the responsibility of the winner.

5.4 The Promoter reserves the right to substitute the Prize with a prize of equal or greater value if circumstances beyond its control make this necessary.

6. Winner Selection and Notification

6.1 The winner will be selected at random from all valid entries across both platforms within 5 working days of the closing date.

6.2 The winner will be notified by direct message from the official Clayton Hotels account only. The winner must respond within 7 days of notification to claim the Prize. If the winner does not respond within this period, the Promoter reserves the right to select an alternative winner by the same method.

6.3 Beware of scam accounts. The Promoter will never ask entrants for payment details, bank information, or fees of any kind. Any such request is fraudulent and should be reported to the relevant platform.

7. Publicity and Winner Details

7.1 The winner's first name may be announced on the Promoter's social media channels.

7.2 In accordance with UK advertising regulations, the surname and county of the winner will be made available on request to anyone who writes to the Promoter at the address above within one month of the closing date, unless the winner objects. Winners may object to this disclosure by contacting the Promoter, though the Promoter must still provide this information to the Advertising Standards Authority if required.

8. Data Protection

8.1 Personal data provided by entrants will be used solely for the purpose of administering this competition and will be processed in accordance with the General Data Protection Regulation (EU) 2016/679, the UK GDPR, and the Promoter's privacy policy, available at <https://dalatahotelgroup.com/privacy-policy/>.

8.2 Entrants' data will not be shared with third parties except as necessary to administer the competition, and will not be retained longer than necessary.

9. General

9.1 By entering, entrants agree to be bound by these terms and conditions.

9.2 The Promoter reserves the right to cancel, suspend, or amend the competition where it becomes necessary to do so due to circumstances beyond its reasonable control.

9.3 The Promoter reserves the right to disqualify any entrant whose entry or conduct is contrary to the spirit of these terms and conditions or the platform's community guidelines.

9.4 The Promoter's decision is final and no correspondence will be entered into.

9.5 These terms and conditions are governed by the laws of the Republic of Ireland, and entrants submit to the non-exclusive jurisdiction of the Irish courts. Nothing in these terms affects the statutory rights of entrants resident in the United Kingdom.
