## VOTE BY PROXY 2025 AGM

**Can't attend the BCLNA's 72nd Annual General Meeting?** Please complete and remit your Proxy to ensure your vote is registered, and BCLNA meets its quorum.

### Howto register your proxy:

- You must be a BCLNA "ACTIVE" or "ASSOCIATE" member to vote. If you will not be attending the AGM you are requested to vote by PROXY.
- Interim, Horticulturist, Honorary, Out of Province, Alumni and Student members are not entitled to vote.
- Obtain permission from a voting Active or Associate member of your choice who will be attending the AGM to act as your proxy.
- Explain to your Proxy how you want them to vote by contacting him or her directly; otherwise, the proxy will vote on your behalf as he or she sees fit.
- Your proxy will vote on any resolutions, the election of Directors and on any motions proposed at the meeting.
- Alternatively, you may designate a BCLNA Director to act as your proxy. If you do not specify a proxy, it will be given to one of the directors attending the AGM. (Staff cannot vote on your behalf).
