- Liquids should not be set on or placed near the cabinet.
- Never unplug from the outlet when your hands are wet.
- Do not use an extension cord with this unit.

 Repairs should always be performed by a qualified electrician.
- Before using any new charging cabinet, have a qualified electrician verify the current draw does not exceed the rating of the unit when all the devices are installed.
- Never plug in if the switch, receptacles, or power cord are broken, cracked, torn or inadequately repaired.


POWER REQUIREMENTS

THE ELECTRICAL SYSTEM IS DESIGNED TO HANDLE A MAXIMUM OF 15 AMPS.

If your devices use 90 watt AC Adapters or higher, you may need to reduce the total number of devices in order avoid overloading your circuit breaker.



Review your power adapter requirements:



If wattage exceeds 15 Amps or about 1500 Watts at one time, you may trip a circuit breaker; Remove devices accordingly.

MOUNTING TO A WALL


The **AC-VERT-16** is designed to be mounted to a wall and must be installed by a qualified technician. Before mounting, use a level and measure the mounting holes.

Use appropriate fasteners (not included) to secure to the wall.

Warning:

The supporting surface must be able to safely support the combined load of cabinet, equipment and hardware. Falling objects may cause serious injury.

O Select a location with easy access to an electrical outlet. Ensure the placement can handle the combined weight of both equipment and cabinet.



Measure the Wall Mount Holes, then drill into wall and with a helper, screw cabinet into place using your own hardware.



To access Wall Mounting Holes, unlock and open both the AC Adapter Panel and Front Door. Remove Panel by tilting forward, then pull out.



4 Once mounting is complete,
Plug your cabinet into an electrical outlet.




SETTING UP POWER ADAPTERS

USER GUIDE

Unlock the AC Adapter Panel with the supplied key. Remove Panel by tilting forward, then pull out. Set aside.



Mount up to two AC Adapters using cable ties or Hook-and-Loop tape (not included). Place the Plate into the cabinet.




5 Tighten the thumbscrews on the Mounting Plate and plug in the AC CORD into the power strip outlet.


Repeat steps 1 - 5 for additional devices.

2 If you would like to secure AC Adapters, remove thumbscrews on each side of the AC Adapter Plates, pull up to remove.



4 Feed the DC CABLE through the FEED-THRU HOLE and connect the end to the Device.





ELECTRICAL TROUBLESHOOTING

Devices are not charging:

Verify power cord is secure and not unplugged. If necessary, using another device, determine if your electrical outlet is working properly.



Some Devices are not charging:

Check each power adapter plug to make sure they are fully inserted.



Overloaded Circuit:

Verify maximum load of all devices is under 1500 watts if plugged into the same circuit.



If wattage exceeds 15 Amps or about 1500 Watts at one time, charging system may not operate correctly; Remove devices.

Limited Warranty

- 1. The terms below shall have the following definitions for purposes of this Warranty:
- "Client" means the original party purchasing the Products from Anywhere Cart or from an authorized dealer to sell Anywhere Cart branded products.
- "Components" mean the mechanical components of a Product including the locks and hinges.
- "Electronics" mean the power strips. Cords are not warrantied.
- "Frame" means the main frame or chassis of a Product.
- "Products" means any goods and any related services to be supplied by Anywhere Cart to the Client pursuant to the Acceptance of an Order and any other goods or services which Anywhere Cart supplies to the Client from time to time.

Anywhere Cart warrants that the Products to be supplied to Client are free from defects in material and workmanship under normal use and service for which they were intended if, but only if, the Products have been properly installed and operated. Anywhere Cart's obligation under this Warranty is limited to only supplying replacement part(s) for any part(s) which are returned and found to be defective, provided that such part(s) are returned to Anywhere Cart within the following Warranty Period:

- a. With regard to the Frame, the Warranty Period shall be for the life of the Product to Client.
- b. With regard to Components, the Warranty Period shall be for a period of two (2) years from the date of delivery of the Product to Client.
- c. With regard to Electronics, the Warranty Period shall be for a period of two (2) years from the date of delivery of the Product to Client.

Except as prohibited or limited by applicable law, Anywhere Cart does not warrant that the Products meet the requirements of any safety code of any country, state, municipality, or other jurisdiction, and Client assumes all risk and liability whatsoever resulting from the use thereof, whether used singly or in combination with other machines or apparatus.
