

## 5. FIREFIGHTING MEASURES

5.1	Fire & Explosion Hazards:	This product is not flammable. However, if involved in a fire, this product may decompose at high temperatures to form toxic gases (e.g., CO, CO <sub>2</sub> ).

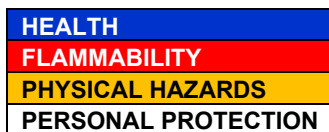

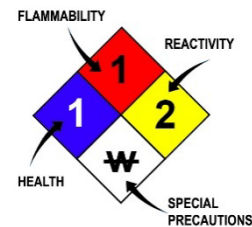
