

- 3. Connect the DPX-XT-TX to the the DPX-XT-RX with one CAT 5e/6/6a UTP (Unshielded Twisted Pair) cable.
- 4. Connect the power to the DPX-XT RX and the DPX-XT TX.
- 5. Power on the display and then the computer.
