Macro location

The Netherlands has approximately 140,000 km of roads, including about 2,800 km of highways.

Vianen is located in the centre of the Netherlands with a very good connection to all directions for example to the ports of Antwerp, Rotterdam and Amsterdam.

The Vianen region is connected by water (1 barge terminal, 19 km distance) allowing companies to optimize the supply of goods.

From Vianen there is excellent transit to north, south, east and west of the Netherlands, making Vianen an ideal location for national or Benelux distribution.

The Vianen region has been a logistics hotspot in the Netherlands for decades and continues to prove itself as a good location centrally located in the country and where more than 16 million inhabitants live within a 100 km range.



Micro location

Vianen is a medium sized city in the province Utrecht, located just south of Utrecht in the centre of the Netherlands.

The market of the Vianen region has a national character and is strongly related with distribution networks. The geographical position in the heart of the country as well as its accessibility by car are the main driving factors for its popularity as a domestic distribution hub.



The property is located on the inter section of motorways A2 (north-south connection: Amsterdam –Utrecht –Eindhoven –Maastricht) and at the A27 from Belgium towards the northeast of the Netherlands (Antwerp–Breda – Utrecht –Almere). As well close to the important motorways A12 (west-east connection: The Hague –Utrecht –Arnhem –Germany).

By public transport the property is easily accessible, the bus stop is within walking distance of the property.


















Floor plan | ground floor
