EXECUTIVE SUMMARY

JLL is pleased to offer for sale a 100 percent fee simple interest in Milford Regional Health Complex in Northbridge, Massachusetts (the "Property" or "Buildings"). The Property is located in the expanding Worcester metropolitan statistical area ("MSA") that has benefited from the rapid growth of the city of Boston less than one hour away.

The Property consists of two buildings that total 38,401 rentable square feet. 100 Commerce Drive was constructed at the request of Milford Regional Medical Center ("MRMC") in 2014 and 200 Commerce Drive was added in 2016 to accommodate MRMC's need for additional space. The Buildings are among the most recently constructed in the submarket and the exceptional quality insulates the Buildings from competition. MRMC directly occupies or guaranties 83 percent of the rentable area under three leases with 13.8 years of WALT remaining. The remaining nine percent of occupied area is leased to Interscope, Inc. under a new, seven year lease.

The recently constructed Buildings are of the highest quality in the submarket and feature desirable health system tenancy and critical medical uses. The Property is available fee simple and free and clear of any mortgage debt.

PROPERTY OVERVIEW

Milford Regional Health Complex consists of two buildings that total 38,401 rentable square feet located 30 minutes from Worchester and less than an hour from Boston. Easily accessible via Massachusetts Route 122, the Property sits only six miles west of Milford Regional Medical Center. Constructed in 2014 at the request of Milford Regional Medical Center, 100 Commerce Drive is a 23,656 rentable square foot medical office building that contains an urgent care, x-ray and laboratory. 200 Commerce Drive is a 14,745 rentable square foot building located adjacent to 100 Commerce Drive and was constructed in 2016 to accommodate Milford Regional Medical Center's need for additional primary care space. The Property's location in a demographically desirable location within Milford Regional Medical Center's patient service area led Milford Regional Medical Center to request the site be developed for their use. As sites for primary care, these build to suit medical facilities and the employed physician group are a critical part of MRMC's outpatient strategy by growing revenue through referrals to the hospital.
