Altea Active, a luxury health and wellness lifestyle brand, operates four premium fitness clubs in Winnipeg, Toronto, Ottawa, and Vancouver and are continuing to expand across the country. The company focuses on offering upscale fitness experiences, combining wellness, social spaces, and community engagement. In 2019, Altea launched its initial club in Winnipeg, highlighting its commitment to premium fitness amenities. It further expanded into Toronto in 2022, Vancouver in 2023 and its largest facility yet in Ottawa in 2024. Avant by Altea, a luxury spin-off concept, is opening in early 2025 in Toronto's Yorkville neighbourhood.

Altea Active was launched in 2017 by David Wu and Michael Nolan and was created to expand the Canadian luxury fitness market and change the way people look at premium fitness and wellness. Altea Active offers specialized boutique fitness studios within a large format setting. Altea is focused on serving the underserved Canadian luxury fitness market. In 2024, Altea strengthened its presence with strategic leadership under CEO Jeff York. York spearheaded the nationwide expansion of Giant Tiger and was the co-CEO of Farm Boy. Altea Active is headquartered in Ontario.

Altea Active Winnipeg ended 2024 with over 10,000 members and crossed \$12.0 million in revenue.










Site Plan



Location Overview

Centrally situated within the thriving Bridgwater residential community, the Property spans 5.84 acres along South Town Road, between Kenaston Boulevard and Centre Street. Bridgwater is a growing southwest Winnipeg community with continuous single family and multifamily residential growth, creating strong, built-in demand for amenities such as the fitness centre. The Property also benefits from substantial exposure to high traffic flows and direct access via Kenaston Boulevard, a major north-south thoroughfare connecting the Bridgwater community to Winnipeg's interior ring highway. The area is further enhanced by its proximity to Victoria General Hospital, the University of Manitoba, and Kenaston Retail Node.

The Bridgwater community featured 1,643 single-family homes in 2019 and is projected to grow to 3,038 homes by 2029 within a 1 km radius. In the broader 5 km area, the residential base will expand from 27,534 homes in 2019 to 36,157 by 2029, driven by the area's sustained residential development. Strategically positioned, the Property is also surrounded by some of Winnipeg's most affluent and established residential neighborhoods, including Bridgwater, South Pointe, Linden Woods, Linden Ridge, and Whyte Ridge along Kenaston Blvd.

The Property is adjacent to grocery-anchored retail at Bridgwater Town Centre, with notable tenants including Save-On Foods, Co-Op Gas Bar, MBLL, Shoppers Drug Mart, Royal Bank, TD Bank and Tim Hortons.

Bridgwater Town Centre is an amenity-rich, walkable community, thoughtfully designed with wide sidewalks and landscaped pedestrian plazas. Bridgwater Town Centre serves as a key commercial and community hub, uniquely positioned to meet the demands of the region's expanding population while capitalizing on its strategic location in one of Winnipeg's most sought-after residential and retail markets. Specifically, Centre Street serves as a key arterial route, seamlessly connecting the Altea Property to all surrounding retail in Bridgwater including Bridgwater Town Centre.
