Place Hurteau counts five buildings, totaling 100 units. The suites range from two to four bedrooms, and feature multiple amenities, including multiple stories, private backyards and direct parking garage access. Each building also offers residents on-site laundry facilities and indoor parking and the site offers a common, newly constructed pool.

The Property affords significant value-add potential: The current rents are well-below market averages and substantial upside could be generated by modernizing suites and common areas and optimizing operating expenses. There is also the potential to develop an additional building on the site.

The Property benefits from a strategic location in the heart of one of the West Island's most populated cities of Dollard-des-Ormeaux. It is known for being one of the Greater Montreal's most diverse communities and is located within minutes from two popular commercial arteries, namely St-Jean Boulevard and Sources Boulevard. It is minutes from both the STM Terminus out of CF Fairview Pointe Claire and the upcoming REM station and its proximity to Highway 40 offers unparalleled access to the Greater Montréal Area. Finally, its location boasts many parks, schools, and services, which offer an incomparable quality of life.








# Investment Highlights

- Residents enjoy the proximity of a Maxi grocery store approximately one kilometre away as well as multiple retail nodes, such as CF Fairview Pointe Claire, home to Simons, Uniqlo, Sports Experts, Lululemon, to name a few, as well as Saint-Jean and Sources Boulevards which boast additional retail and essential services options.
- Having a Costco just 2 kilometres away from the Property offers incredible convenience, providing easy access to bulk shopping for groceries, household essentials, and a wide range of products at competitive prices.
- Residents can also benefit from the close proximity to Marché de l'Ouest, a beloved local farmers' market offering a diverse selection of fresh produce, artisanal products, and gourmet foods, providing a unique shopping experience and access to high-quality, locally-sourced items year-round.
