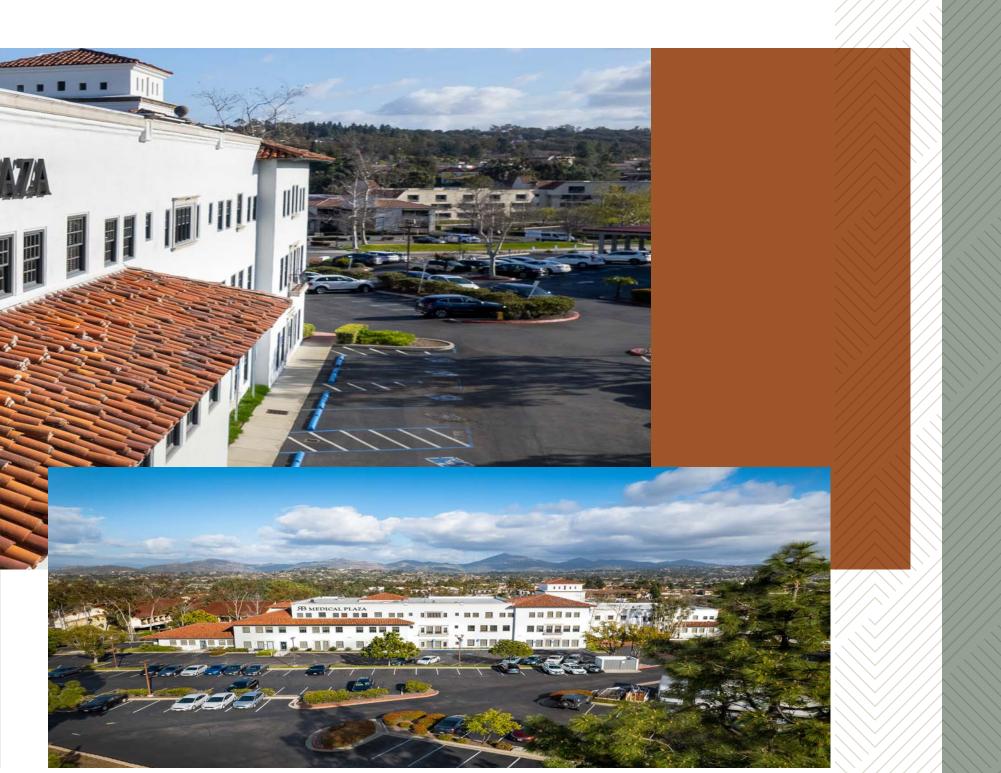

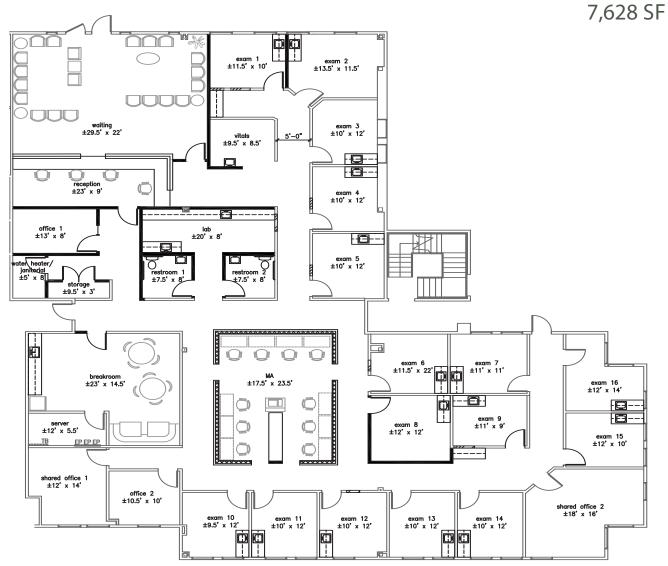

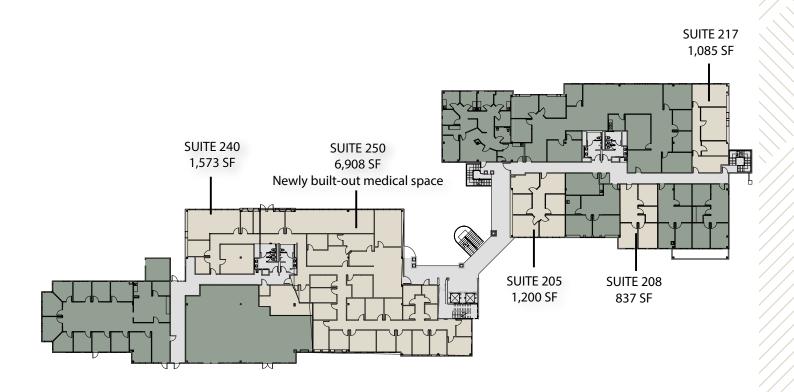
HYPOTHETICAL SPACE PLAN

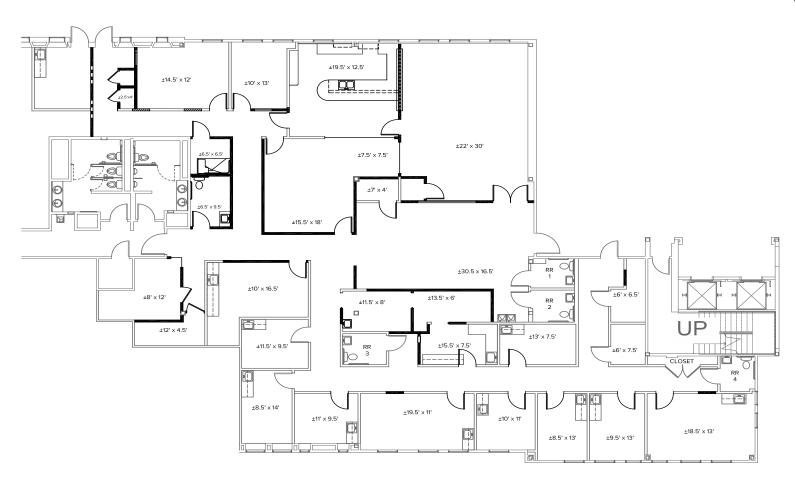




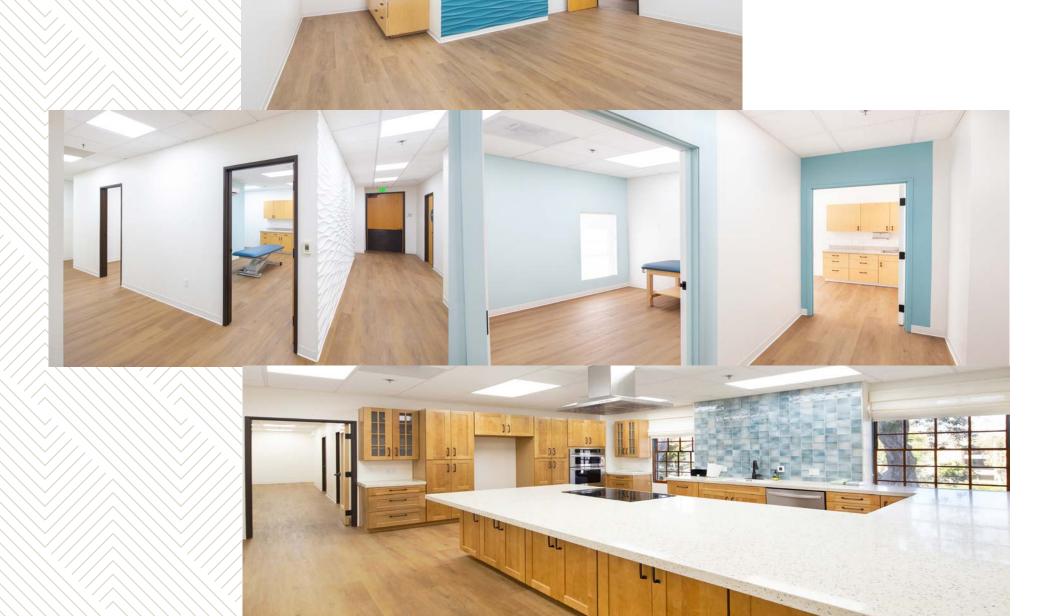
2ND FLOOR

NEWLY IMPROVED MEDICAL OFFICE

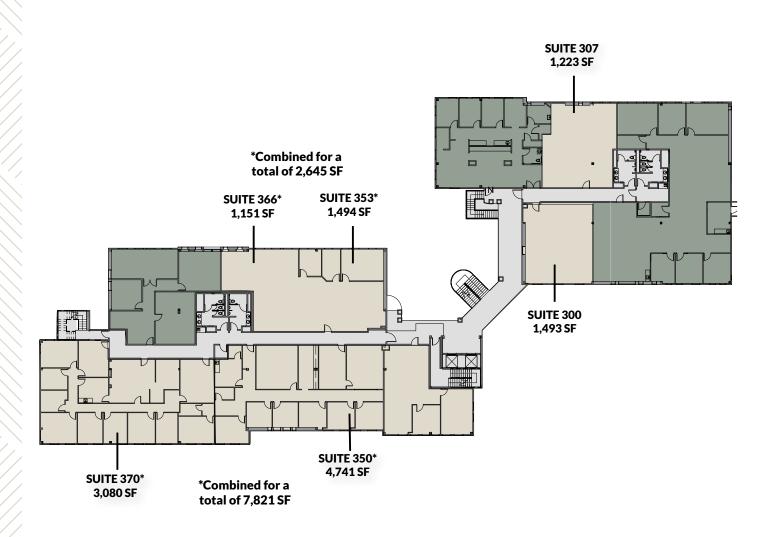

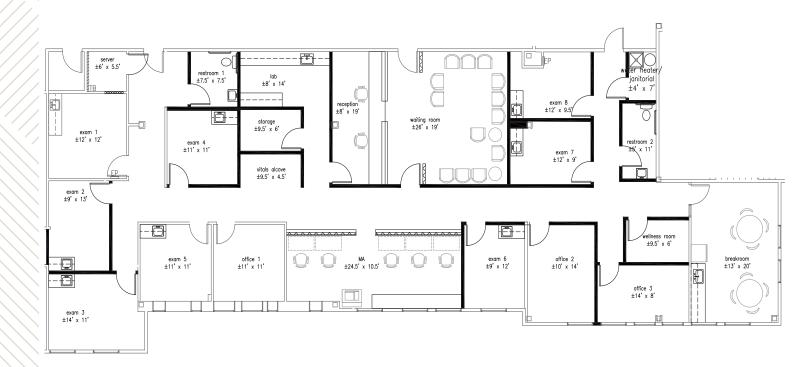


3RD FLOOR SUITE 300 | 307 | 350 | 353 | 366 | 370

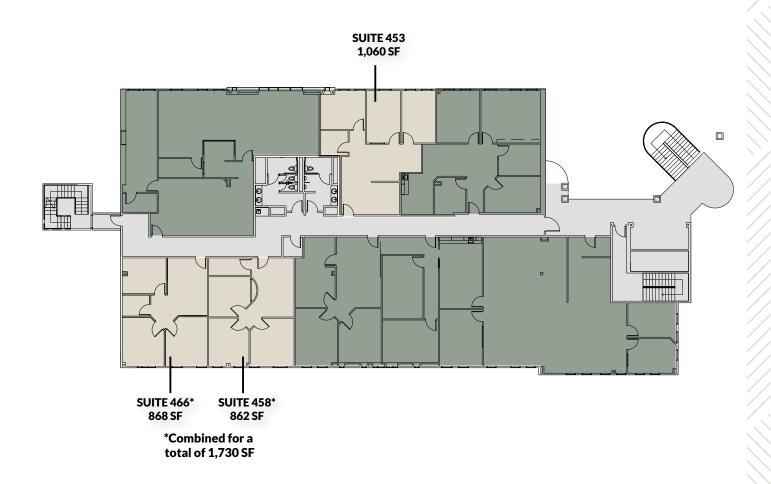




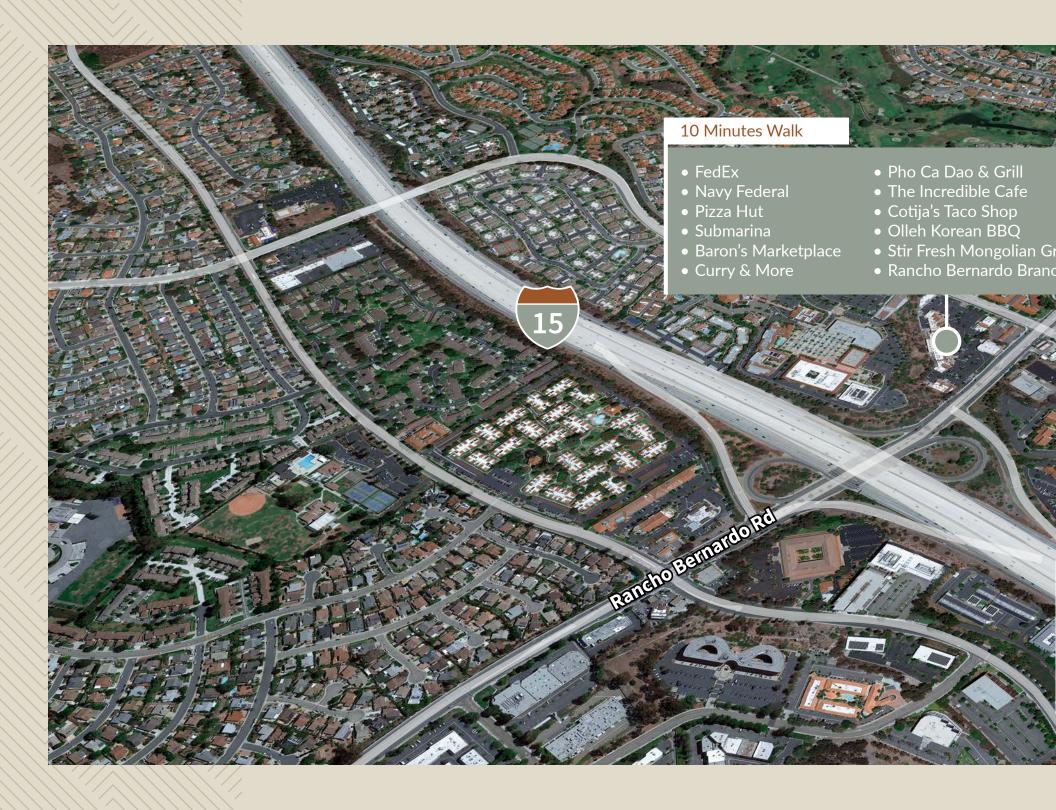
3RD FLOOR SUITE 350 HYPOTHETICAL SPACE PLAN 4,741 SF
